No. PAS/Legis-B-13/73.—The Sind Finance Bill, 1973 having been passed by the Provincial Assembly of Sind on the 27th June, 1973 and assented to by the Governor of Sind on the 28th June, 1973 is hereby published as an Act of the Legislature of Sind:—

It is hereby enacted as follows: -

Short title. extent and commencement,

- 1. (1) This Act may be called the Sind Finance Act, 1973.
 - (2) It extends to the whole Province of Sind.
 - (3) It shall come into force on and from the 1st day of July,

Definitions.

- 2. In this Act, unless the context other-wise requires, the follo expressions shall have the meanings hereby respectively assigned to t that is to say-
 - (a) "Government" means the Government of Sind:
 - (b) "prescribed" means prescribed by rules made under this Ac

Amendment of Section 3 of West Pakistan Act V of 1958.

- 3. In the Sind Urban Immovable Property Tax Act, 1958 (Pakistan Act V of 1958), in section 3—
 - (a) in sub-section (2), for the word "paid", the word "collection" shall be substituted and shall be deemed to have always so substituted;
 - (b) after sub-section (3), the following new sub-sections shall inserted, namely: -
 - "(3-A) There shall be levied and collected a bettermen on buildings and lands used partly or exclusively for comme or industrial purposes at the following scale:--
 - (i) Plot for Commercial purpose.
- Ten paisa per square foot of cov area.
 - purpose.
 - (ii) Plot for Industrial Five paisa per square foot of cov
 - (3-B) A plot for commercial purpose measuring upto square yards and a plot for industrial purpose measuring upto square yards in any rating area or part thereof shall be exfrom the tax under sub-section (3-A)".

Amendment of Section 6-A of, and Schedule to, West Pakistan Act X of 1958.

- 4. In the West Pakistan Entertainments Duty Act, 1958 (West Pak Act X of 1958), in its application to the Province of Sind—
 - (1) in secion 6-A-
 - (a) in sub-section (1)—
 - (i) the words, figures and comma "or in section 8 of the Pakistan Finance Ordinance, 1969" shall be omitted;

- (ii) in clauses (a) and (b), the words, figures and comma "and the Welfare Cess under the West Pakistan Finance Ordinance, 1969" shall be omitted; and
- (iii) in clause (c), the words, figures and commas "and the Welfare Cess under section 8 of the West Pakistan Finance Ordinance, 1969," shall be omitted.
- (b) in sub-sections (2), (5), (6) and (8) and proviso to subsection (8), the words "and the Welfare Cess" shall be omitted:
- (c) in sub-section (4), the words, figures and commas "and the Welfare Cess under the West Pakistan Finance Ordinance, 1969," shall be omitted; and
- (d) clause (b) of the explanation shall be omitted; and
- (2) in the heading of column 2 of the Schedule, the words "and Welfare Cess" shall be omitted.
- 5. In the West Pakistan Finance Act, 1963, (West Pakistan Act IX of Amendment 1963), in its application to the Province of Sind, in the Seventh Schedule, in Seventh the column of rate of tax—

- (a) for the figures and words "7½ per cent", the figures and words Act IX of "10 per cent" shall be substituted, and
- (b) for the figures and words "10 per cent", the figures and words "15 per cent" shall be substituted.

In the West Pakistan Finance Act, 1964 (West Pakistan Act Amendment XXXIV of 1964), in its application to the Province of Sind, in section 12, of section 12 of West in sub-section (1) and the proviso thereto, for the words "twelve paisa", Pakistan the words "eighteen paisa" shall be substituted.

7. In the West Pakistan Finance Ordinance, 1969, (West Pakistan Amendment Ordinance VII of 1969), in its application to the Province of Sind, in sub- of west section (1) of section 8—

8. No suit shall lie in any civil court to set aside or modify any asses ment, levy or collection of the taxes and cesses made under this Act and the rules framed thereunder.

Power to make rules.

9. Government may make rules for carrying into effect the purpos of this Act and such rules may among other matters, prescribe the proc dure for the assessment, collection and payment of the taxes and cess levied under this Act.
