## THE SINDH EPIDEMIC DISEASES (AMENDMENT) ORDINANCE, 2020

Sindh Ordinance No.II of 2020 (here print as in the accompaniment)

#### AN ORDINANCE

to amend the Sindh Epidemic Diseases Act, 2014.

WHEREAS it is expedient to amend the Sindh Epidemic Preamble. Diseases Act, 2014, in the manner hereinafter appearing;

AND WHEREAS the Provincial Assembly is not in session and the Governor is satisfied that circumstances exists which render it necessary to take immediate action;

NOW, THEREFORE, in exercise of the powers conferred by clause (1) of Article 128 of the Constitution of the Islamic Republic of Pakistan. 1973, the Governor is pleased to make and promulgate the following Ordinance:-

t. (1) This Ordinance may be called the Sindh Epidemic Diseases (Amendment) Ordinance, 2020.

Short title and commencement.

- (2) It shall come into force at once.
- 2. In the Sindh Epidemic Diseases Act, 2014, hereinafter referred to as the said Act, in section 3, in sub-section (3), after the words "Deputy Commissioner", the words "or Assistant Commissioner or any other Officer" shall-be inserted.

Amendment of section 3 of Sindh Act No.VIII of 2015.

3. In the said Act, for section 4, the following shall be substituted:-

Substitution of section 4 of Sindh Act No.VIII of 2015.

"4. Penalty. (1) Whoever contravenes or disobeys the orders passed by the Government or the officers empowered or the regulations made under this Act, without prejudice to any punishment to which he may be liable under any other law for the time being in force, shall be punishable with on spot fine upto rupees one million or attachment of movable, immovable, perishable property or both:

Provided that the order of imposing the penalty shall be in writing containing reasons for the issuance of the order thereof.

(2) The fine prescribed under sub-section (1) shall be recovered as arrears of land revenue under the Sindh Land Revenue Act, 1967 (Act No.XVII of 1967)."
