Notification No. SORI(S&GAD)2-4/2000(B) :- In exercise of the powers conferred by section 10 read with section 5 of the Sindh Public Service Commission Act, 1989, the Governor of Sindh is pleased to make the following rules :-

PART-I
GENERAL

1. Short title and commencement :-
 - 1) These rules may be called the Sindh Public Service Commission (Conditions of Service) Rules, 2002.
 - 2) They shall come into force at once.
2. Definitions :-
 - a) "Chairman" means the Chairman of the Commission;
 - b) "Schedule" means the Schedule to these rules.
3. Allowances and perquisites of Chairman and Member :- The Chairman and a Member shall be entitled to pay, allowance and perquisites as specified in the Schedule.
4. Pension :- The Service as Chairman or Member shall not qualify for pension except that Chairman or, Member who immediately before his such appointment was in service of Pakistan shall be entitled to pension for the period he was in service.
5. Leave :-
 - 1) The Chairman or a Member before his such appointment was in service of Pakistan shall be granted leave in accordance with the rules applicable to him immediately before the said appointment and his service as Chairman or Member shall count for such leave.
 - 2) The Chairman or a Member whose case is not covered by sub-rule (1) shall be granted leave as follow :-
 - a. Leave salary equivalent to full pay upto one eleventh of the period spent on duty as Chairman or Member subject to a maximum of four months at any one time;

- b. Leave Ex-Pakistan or leave on medical ground on leave salary equivalent to half pay upto one twelvth of the period spent on duty as Chairman or Member subject to a maximum of three months at any one time;
- c. Extra-ordinary leave without salary for any period.
6. Medical facilities :- The Chairman or a Member shall be entitled to the medical facilities admissible under the Sindh Civil Servants (Medical Attendant) Rules, 1993 amended from time to time :
- Provided that the Chairman or Member who immediately before his appointment as Chairman or Member was in service of Pakistan may be governed by the rules applicable to him before such appointment.
7. Repeal :- The Sindh Public Service Commission (Conditions of Service) Rules, 1981 are hereby repealed.
