THE MEHRAN ENGINEERING AND TECHNOLOGY UNIVERSITY
(AMENDMENT) ACT, 1986

[26TH November 1986].

An Act to amend The Mehran University of Engineering And Technology Act, 1977.

WHEREAS it is expedient to amend The Mehran University of Engineering and Technology Act, 1977, in the manner hereinafter appearing; **Preamble.**

It is hereby enacted as follows: —

1. (1) This Act may be called the Mehran Engineering and Technology University (Amendment) Act, 1986. **Short title and commencement.**

(2) It shall come into force at once.

2. In the Mehran University of Engineering and Technology Act, 1977, hereafter referred to as the said Act, in section 2, after clause (1), the following shall be inserted :— **[Amendment of section 2 of Sind Act IV of 1977.](#)**

“(11) “Pro-Vice-Chancellor” means the Pro-Vice-Chancellor of the University;”.

3. In the said Act, in section 15, in sub-section (1), after clause (i), the following shall be inserted :— **[Amendment of section 15 of Sind Act IV of 1977.](#)**

“(i-a) the Pro-Vice-Chancellor;”.

4. In the said Act, in section 17, in sub-section (1), after clause (i), the following shall be inserted :— **[Amendment of section 17 of Sind Act IV of 1977.](#)**

“(i-a) the Pro-Vice-Chancellor;”.

5. In the said Act, in section 26, after clause (i), the following shall be inserted :— **[Amendment of section 26 of Sind Act IV of 1977.](#)**

“(i-a) the Pro-Vice-Chancellor;”.

6. In the said Act, after section 28, the following shall be inserted :— **[Insertion of section 28-A in Sind Act IV of 1977.](#)**

Pro-Vice-Chancellor

28-A. (1) The Chancellor may in consultation with the Vice-Chancellor, appoint a Pro-Vice-Chancellor for the main campus or for additional campus, it any, or for both the

campuses jointly or separately, on such terms and conditions and for such period not exceeding four years at a time as the Chancellor may determine.

(2) Where a Pro-Vice-Chancellor is appointed under sub-section (1), he shall, notwithstanding anything contained in this Act, exercise such powers and perform such functions of the Vice-Chancellor or such other powers and functions, in respect of the campus for which he is appointed as the Chancellor may delegate to him.”.

7. The Mehran Engineering and Technology University (Amendment) Ordinance, 1986, is hereby repealed.
