

## SINDH ORDINANCE NO. V OF 2002

### THE SINDH UNIVERSITY AND INSTITUTES LAWS (AMENDMENT) ORDINANCE, 2002.

[13<sup>th</sup> FEBRUARY, 2002]

An Ordinance to amend certain laws relating to the Universities and other educational Institutes in force in the Province of Sindh.

**WHEREAS** it is expedient to amend laws relating to the Universities and other educational Institutes in force in the province of Sindh, in the manner hereinafter appearing; **Preamble.**

**AND WHEREAS** the Provincial Assembly stands dissolved in pursuance of the proclamation of the fourteenth day of October, 1999, and the Provisional Constitution Order No. 1 of 1999.

**AND WHEREAS** the Governor of Sindh is satisfied that circumstances exist which render it necessary to take immediate action.

**NOW, THEREFORE,** in pursuance of the aforesaid Proclamation and the Provisional Constitution Order read with Provisional Constitution (Amendment) Order No. 9 of 1999, and in exercise of all powers enabling him in that behalf, the Governor of Sindh is pleased to make and promulgate the following Ordinance:-

1. (1) This Ordinance may be called the Sindh Universities and Institutes Laws (Amendment) Ordinance, 2002. **Short title and commencement.**

(2) It shall come into force at once.

#### PART – I UNIVERSITIES LAWS

1. In the University of Sindh Act, 1972 and the University of Karachi Act, 1972, in section 22, in sub-section (1), in clause (v) and section 24, in sub-section (1) in clause (vii), before the semicolon, the words "or his nominee not below the rank of an Additional Secretary" shall be inserted. [Amendment of section 22 and 24 of Sindh Act XXIV and XXV of 1972.](#)

2. In the N.E.D. University of Engineering and Technology Act, 1977, in section 15, in sub-section (1), in clause (vi) and in the section 17, in sub-section (1), in clause (vii) and in the Mehran University of Engineering and Technology Act, 1977, in section 15, in sub-section (1), in clause (vi) and in section 17, in sub-section (1), in clause (vii), before the semi-colon, the words "or his nominee not below the rank of an Additional Secretary" shall be inserted. [Amendment of section 15 and 17 of Sindh Act III and IV of 1977.](#)

3. In the Sindh Agriculture University Act, 1977, in section 15, in sub-section (1), in clause (v) and in section 17, in sub-section (1), in clause (vi) before the semi-colon, the words "or his nominee not below the rank of an Additional Secretary" shall be inserted. [Amendment of section 15 and 17 of Sindh Act V of 1977.](#)

4. In the Shah Abdul Latif University Act, 1986, in section 23, in sub-section (1), in clause (viii) and in section 25, in sub-section (1), in clause (vii), before the semi-colon, the words "or his nominee not below the rank of an Additional Secretary" shall be inserted. [Amendment of section 23 and 25 of Sindh Act XI of 1986.](#)

In the Qaid-e-Awam University of Engineering, science and Technology Nawabshah Act, 1996, in section 15, in sub-section (1), in clause (vi), and in section 17, in clause (viii), before the semi-colon, the words "or his nominee not below the rank of an Additional Secretary" shall be inserted. [Amendment of section 16 of Sindh Act V of 1997.](#)
9. In the Isra University Act, 1997, in section 16, in sub-section 16, in sub-section (1), in clause (v), before the semi-colon, the words "or his nominee not below the rank of an Additional Secretary" shall be inserted. [Amendment of section 12 of Sindh Act I and IV of 1998.](#)
10. In the Greenwich University Act, 1997 and in the Jinnah University for Women Act, 1998, in section 12, in sub-section (1), in clause (c), before the semi-colon, the words "or his nominee not below the rank of an Additional Secretary" shall be inserted. [Amendment of section 10 of Sindh Ordinance IV of 2000.](#)
11. In the Muhammad Ali Jinnah University Ordinance, 2000, in section 10, in sub-section (1), in clauses (c), before the semi-colon, the words "not below the rank of an Additional Secretary" shall be inserted. [Amendment of section 10 and 13 of Sindh Ordinance VI of 2000.](#)
12. In the Iqra University Ordinance, 2000, in section 10, in sub-section (1), in clause (c), before the full stop, the words "not below the rank of an additional Secretary" shall be inserted and in section 13, in sub-section (1), for clause (v), the following shall be substituted:-  
"(v). the Secretary to Government of Sindh, Education Department or his nominee not below the rank of an Additional Secretary;"
13. In the Liaquat University of Medical and Health sciences Ordinance, 2000, in section 24, in clause (v) and in section 26, in sub-section (1), in clause (viii), before semi-colon, the word "or his nominee not below the rank of an Additional Secretary" shall be inserted. [Amendment of section 24 and 26 of Sindh Act VII of 2001.](#)

#### PART-II INSTITUTED LAWS

1. In the Indus Valley School of Art and Architecture at Karachi Act, 1994, in section 13, in subsection (1), in clause (c), before the semi-colon, the words "or his nominee not below the rank of an Additional Secretary" shall be inserted. [Amendment of section 13 of Sindh Act, XVI of 1994.](#)
2. In the Institute of Business Administration Act, 1994, in section 12, in sub-section (1), in clause (v), before the full stop, the words "or his nominee not below the rank of an Additional Secretary" shall be inserted. [Amendment of section 12 of Sindh Act, XX of 1994.](#)
3. In the Shaheed Zulfiqar Ali Bhutto Institute of Science and Technology Act, 1995-
  - (i) in section 15, in sub-section (1), for clause (j), the following shall be substituted:-

"(j) secretary to Government of Sindh, Education Department or his nominee not below the rank of an Additional Secretary. ";
  - (ii) in section 18, in sub-section (1), in clause (vi), for the words "Deputy Secretary" the words "Additional Secretary" shall be substituted.

In the Karachi Institute of Economics and Technology Ordinance, 2000, in section 13, in sub-section (1), in clause (f), before the semi-colon, the words "not below the rank of an Additional Secretary" shall be inserted. 6. In the Sindh (Textile Institute of Pakistan) Ordinance, 2001, in section 11, sub-section (1), in clause (c), and in section 16, in sub-section (2), in clause (v), after the word "nominee" the words "not below the rank of an Additional Secretary" shall be inserted respectively. [Amendment of section 14 of Sindh Ordinance XXII of 2001.](#)
7. In the khadim Ali Shah Bukhari Institute of Technology Ordinance, 2001-
  - (i) in section 14, in sub-section (1), in clause (iv), before the semicolon, the words "not below the rank of an Additional Secretary" shall be inserted;
  - (ii) in section 17, in sub-section (1), in clause (vi), for the words "Deputy Secretary", the words "Additional Secretary" shall be substituted.
