## THE SINDH TRAVEL AGENCIES ACT, 2011

[9th June, 2011]

**An Act** to provide for the development, regulation and control of the profession of travel agencies in the Province.

**WHEREAS** it is necessary and expedient to **Preamble.** provide for the development, regulation and control of the profession of travel agencies in the Province;

It is hereby enacted as follows:-

- 1. (1) This Act may be called the Sindh Travel Short title, extent Agencies Act, 2011. and commencement.
- (2) It extends to the whole of the Province of Sindh.
  - (3) It shall come into force at once.
- 2. In this Act, unless there is anything repugnant in **Definitions**. the subject or context -
  - (a) "Committee" means the Travel Agencies Regulatory Committee set up by Government under section 3;
  - (b) "Government" means the Government of Sindh:
  - (c) "Licence" means a licence granted under this Act to any person to operate as a travel agency;
  - (d) "licenced guide" means a guide licensed under the law for the regulation and control of the profession of tourist guides;
  - (e) "prescribed" means prescribed by rules;
  - (f) "rules" means rules made under this Act;
  - (g) "travel agency" means a person, by whatever name called, who-
    - (i) makes, directly or indirectly, on commercial basis arrangements for the passage of the tourists, or use of transport, or transportation of their baggage or goods by sea, air, rail or road; or

- (ii) makes arrangements for lodging, transport or other services relating to travel of persons or arranges entertainment, sight-seeing, excursion and guide services, whether the arrangements made on the basis of comprehensive all inclusive rates or on the basis of separate charges for each service provided; or
- (iii) has been delegated general authority in respect of sales for the airlines or other carriers, either directly or through a sub-contract; and
- (h) "tourist" means a person normally residing out-side Pakistan who enters Pakistan and remains therein for not less than twenty – four hours and nor more than six months in the course of any year for purposes such as touring, recreation, sports, health, study, religious pilgrimages or business, and includes a citizen of Pakistan who travels within Pakistan or proceeds abroad for any of the said purposes.
- 3. (1) As soon as may be after the commencement of this Act, Government shall set up a committee to be known as the Travel Agencies Regulatory Committee consisting of a Chairman and
- the **Committee**.
- (2) The Chairman and other members of the Committee shall hold office during the pleasure of Government on such terms and conditions as Government may determine.

- (3) The Committee shall perform the following functions, namely:-
  - (a) advise Government in the implementation of the provisions of this Act and the rules:
  - (b) approve the rates of service charges of travel agencies in respect of various services rendered by them to the tourists;

- (C) advise Government from time to time in respect of licence fees to be prescribed for various services rendered by the travel agencies;
- (d) Government assist in the preparation of a code of conduct for travel agencies; and
- functions (e) such other connected with the objects of this Act and as Government may entrust to it.
- Any person operating or intending to Licensing of (1) organize and operate a travel agency shall apply to travel agency. Government on the prescribed form for the grant of a licence.

- Subject to sub-section (3), on receipt of an application under sub-section (1), Government may, on payment of the prescribed fee by the applicant, grant to the applicant a licence in the prescribed form.
- A licence shall not be granted to an applicant if
  - the applicant, or the manager or (a) any partner or director of the applicant, has been convicted of an offence which, in the opinion of Government, involves moral turpitude;
  - (b) the applicant is a minor or insane person;
  - position (c)the financial of the applicants is, in the opinion of Government, such as prevent the applicant from acting as a travel agency efficiently;
  - (d) applicant has the had experience of travel arrangements required to operate the business of a travel agency and has not employed persons who have had such experience; or

- (e) the applicant does not have an office of a prescribed minimum standard or does not engage experienced and trained employees or licensed guides or provide not such transportation facilities as may be prescribed.
- Government shall maintain a register in which the names, address, nature, composition and the field of operation of all licensed travel agencies shall be entered.
- The licence shall, unless earlier cancelled (5) or suspended under section 10 or section 11, remain valid for one year and may be renewed from year to year in such manner, and on payment of such fee, as may be prescribed.
- 5. This Act shall not apply to
  - enterprises operated by Government; (a)

- national carriers of Pakistan and foreign (b) airlines, duly authorized to operate to, from or via Pakistan; or
- any agency, whether private or official, (C)entrusted which is specifically Government with the work relating to handling of Haj pilgrims or other pilgrims, within or without Pakistan, and who are subject to special regulations governing their field of activity.
- 6. Prohibition to act without licence, etc. subject to section 5
  - no person shall hold himself out or act as without license, (i) a travel agency unless he holds a licence;

Prohibition to act etc.

(ii) no airline or other carrier shall delegate general authority in respect of sales, either directly or through a sub-contract, to a person who does not hold a licence.

7. (1) A licensed travel agency shall maintain in a **Business** scheduled bank a business guarantee fund of such guarantee fund. minimum amount or furnish such bank quarantee, as may be prescribed.

- No amount shall be payable out of a (2) business guarantee fund maintained by a licensed travel agency under sub-section (1) except the order of Government.
- Government may, after making such inquiry as it may deem fit and after giving a travel agency an opportunity of showing cause against the order proposed to be made, order payment, out of the business guarantee fund of the travel agency, of any sum owed by the agency to a tourist, carrier, company or hotel or lodging house and not settled by it within thirty days from the date of its becoming due.
- A travel agency from whose business guarantee fund payment of any amount has been made under sub-section (3) shall, within a period of fifteen days of such payment, deposit the said amount into the business guarantee fund.
- The rates of service charges from the Service charges. 8. tourists shall be set out in a rate list drawn up by a licensed travel agency from time to time and approved by the Committee.

- A copy of the rate list referred to in subsection (1) for the time being in force shall be posted at some conspicuous part of the office of the travel agency.
- 9. A licensed travel agency shall, on payment of Alterations. the prescribed fee, have every change in its nature or composition or its field of operation entered in the reaister maintained under section 4, within fifteen days of the day on which such change occurs.

In the case of discontinuance or transfer of **Discontinuance** business, dissolution, re-organisation or winding up of a licensed travel agency, Government shall be informed agency within thirty davs the discontinuance, transfer, dissolution, re-organisation, or winding up and on receipt of the information, Government may either cancel the licence granted to the travel agency or, in the case of transfer of business or re-organisation, grant a new licence to the transferee travel agency or to the travel agency as reorganized.

11. Government may, after affording a licensed Suspension or travel agency an opportunity of showing cause cancellation of against the action proposed to be taken against it by licence. order in writing, suspend the licence of the travel agency for a period not exceeding six months or cancel its licence if the agency-

- violates the provisions of this Act or the (a) rules or the terms and conditions of the licence or the prescribed code of conduct:
- (b) suspends its business without intimation to, or permission of, Government and does not resume it within six months from the date of such suspension or within the time specified by Government;
- (c) contravenes the provisions of sub-section (1) or sub-section (4) of section 7; or
- becomes a person to whom a licence (d) cannot be granted under sub-section (3) of section 4.
- 12. Any traveler having a complaint against any Complaints, travel agency may approach the Committee which shall dispose of the same in the prescribed manner.

appeal and review.

A travel agency aggrieved by the **Decision in** 13. (1) decision or order of an officer or authority other than Government under this Act or the rules may prefer an appeal to Government within the prescribed time and in the prescribed manner, and the decision of Government in such appeal shall be final.

Government may at any time of its own (2)motion, or on the application of any travel agency aggrieved by any decision or order passed by Government under this Act or the rules within the prescribed time and in the prescribed manner, pass such order in relation thereto as it thinks fit:

Provided that no order against a travel agency shall be passed unless it has been given an opportunity of showing cause against it and of being heard.

Any travel agency which contravenes or **Penalty**. fails to comply with the provisions of this Act or the rules or violates the prescribed code of conduct shall, without prejudice to any other action that may be taken against it under this Act, be punishable with fine which may extend to twenty-five thousand rupees.

- No court shall take cognizance of an (2) offence punishable under this Act except upon a complaint made in writing by or under the authority of Government.
- 15. Government may, by notification in the official **Delegation of** Gazette, direct that all or any of its powers under this powers. Act shall, under such conditions, if any, as may be specified, be exercisable also by any officer authority subordinate to Government.

16. Government may, by notification in the **Power to make** official Gazette, make rules for carrying out the rules. purposes of this Act.

- In particular, and without prejudice to the (2)generality of the foregoing power, such rules may provide for all or any of the following matters, namely:-
  - (a) the fees payable for the issue and renewal of a licence, depending on the nature of the services to be rendered by an applicant to tourists and the number of branch offices the applicant proposes to establish;
  - the form in which an application for (b) a licence is to be made:
  - (C) the form of the licence;
  - (d) the code of conduct:
  - the conditions to which a licence (e) shall be subject; and
  - the manner in which, and the time (f) within which, an appeal under this Act may be preferred.
