# NOTIFICATIONS BY THE GOVERNMENT OF SINDH

No. SORI(SGA&CD)1-114/2022:- In pursuance of the provisions of clause (3) of Article 139 of the Constitution of the Islamic Republic of Pakistan, 1973, the Government of Sindh are pleased to make the following amendments in the Sindh Government Rules of Business, 1986 :-

### AMENDMENTS

In Schedule-II

- under the heading "Excise, Taxation & Narcotics Department", in serial No. 2 the words "Urban Immovable Properties" shall be omitted;

- ii. under the heading "**Local Government & Housing Town Planning Department**", after the entry at serial No. 17-B, the following new entry shall be inserted :-

"17-C. Assessment and collection of Urban Immovable Property Tax by the councils in accordance with Entry No. 1 of Part-II of Schedule-V of the Sindh Local Government Act, 2013".

**No.SORI(SGA&CD)7-27/2022:-** In pursuance of the provisions of clause (3) of Article 139 of the Constitution of the Islamic Republic of Pakistan, 1973, the Government of Sindh are pleased to make the following amendments in the Sindh Government Rules of Business, 1986 :-

### AMENDMENTS

1. In Schedule-III, the existing entry appearing at serial No. 3, shall be omitted.
2. In Schedule-IV, after entry at serial No. 1, the following new entry shall be inserted :-  
"1-A. Appointment of Chairperson of Sindh Public Service Commission under Article 242 (1B) of the Constitution".
3. In Schedule-VI, in entry at serial No. 4, after clause (c), the following new entry shall be added :-  
"(D). Appointment of Members of Sindh Public Service Commission".

**No.SORI(SGA&CD)7-27/2022:-** In exercise of the powers conferred by section 12 of the Sindh Public Service Commission Act, 2022, the Government of Sindh are pleased to make the following rules, namely :-

### PART-I PRELIMINARY

1. **Short Title and Commencement.**-These rules may be called the Sindh Public Service Commission (Appointment of Chairperson and Members) Rules, 2022.  
(2) They shall come into force at once.
2. **Definitions.**- (1) In these rules, unless the context otherwise requires -  
(i) "Act" means the Sindh Public Service Commission Act, 2022 (Sindh Act No.IV of 2022);  
(ii) "Committee" means the Permanent High Powered Committee constituted under rule 5;  
(iii) "SGA&CD" means the Services, General Administration & Coordination Department, Government of Sindh.  
(2) The words and expressions used but not defined in these rules shall have the same meanings as assigned to them in the Act.

### PART-II APPOINTMENT AND REMOVAL OF CHAIRPERSON AND MEMBERS

3. **Appointment of Chairperson and Members.**- (1) The Chairperson and Members shall be appointed in accordance with the provisions laid down in section 4 of the Act.

(2) The Members to be appointed under sub-sections (2) and (3) of section 4 of the Act shall be persons of eminence possessing competence, exalted caliber, unblemished track record, impeccable integrity and unquestionable impartiality in their profession.

(3) No person in the service of Government or in autonomous corporation or body established by Government or by law or otherwise shall be appointed as Chairperson or Member.

4. **Removal of Chairperson and Members.** - The Chairperson and Members shall be removed in accordance with the provisions laid down in section 7 of the Act.

### PART-III HIGH POWERED COMMITTEE

5. **High Powered Committee.** - (1) There shall be a Permanent High Powered Committee which shall consist of the following :-

(i)	Chief Secretary, Sindh	Chairperson
(ii)	Secretary to Government of Sindh, Law Department	Member
(iii)	Secretary (Services), SGA&CD, Government of Sindh	Member/Secretary
(iv)	Secretary to Government of Sindh, Culture, Tourism Antiquities & Archives Department	Member
(v)	Secretary to Government of Sindh, Universities & Boards Department	Member
(vi)	Any member to be co-opted by the Chairperson	Co-opted Member

(2) The Committee shall scrutinize and examine the profiles of the Chairperson and Members to be selected under section 4 (1), (2), (3) & (4) of the Sindh Public Service Commission Act, 2022 and rule 3.

(3) The Committee shall, after thorough examination of the profile, recommend the Chairperson and Members in accordance with the parameters laid down under sub-sections (1), (2), (3) and (4) of section 4 of the Act.

(4) The Committee shall check the record of the proposed appointee as well as the ACRs/PERs relating to his whole service career which should be free from any adverse entry.

### PART-IV PROCEDURE OF APPOINTMENT OF CHAIRPERSON AND MEMBERS

6. **Procedure of appointment of Chairperson and Members.** - (1) The Committee shall recommend the panel of at least three persons for the position of Chairperson and Members as per criteria as laid down in sub-sections (1), (2), (3) and (4) of section 4 of the Act and rule 3 *ibid*.

(2) The Chief Minister may interview the recommended candidates and recommend the appropriate person as Chairperson to the Governor and / or select the Members as the case may be.

(3) On receipt of approval of the Governor and the Chief Minister, as the case may be, the appointment of the Chairperson and Members shall be notified by the SGA&CD.

### PART-V FINANCIAL

7. **Financial.**-The Pay, Allowances and Pre-requisites of the Chairperson and Members shall be regulated under the Sindh Public Service Commission (Conditions of Service) Rules.

### PART-VI REPEAL

8. **Repeal.** The Sindh Public Service Commission (Appointment of Chairman and Members) Rules, 2017 shall, on commencement of these rules, stand repealed.
