Preamble

WHEREAS it is expedient to amena certain laws relating to the Private Universities and Educational Institutes in force in the Province of Sindh, in the manner hereinager appearing;

It is hereby enacted as follows:-

### Short title and commencement

- (1) This Act may be called the Private University and Educational Institutes Laws (Amendment) Act, 2004.
