Preamble

WHEREAS it is expedient to amend certain laws relating to the Private Universities and Educational Institutes in force in the Province of Sindh, in the manner hereinafter appearing;

It is hereby enacted as follows:-

Short title and commencement

(1) This Act may be called the Private Universities and Educational Institutes Laws (Amendment) Act, 2004.

(2) it shall come into force at once.

2. The laws specified in column 2 of the Schedule below are hereby amended to the extent and in the manner specified against them in column 3 thereof.

7. The Jinnah University for Women Act, 1998.
In section 12, in sub-section (1), in clause (e), for the words and comma "Chairman, University Grants Commission", the words and comma "Chairperson, Higher Education Commission" shall be substituted.
8. The Muhammad Ali Jinnah University Ordinance, 2000.
In section 10, in sub-section (1), in clause (b), for the words and comma "Chairman, University Grants Commission", the words and comma "Chairperson, Higher Education Commission" shall be substituted.
9. The Isra University Ordinance, 2000.
In section 10, in sub-section (1)-
(i) for clause (c), the following shall be substituted:-
"(c) the Chairperson, Higher Education Commission or his nominee";
(ii) in clause (e), before the full stop, the words "not below the rank of Additional Secretary" shall be inserted.
10. The Defence Housing Authority Sufra University Ordinance, 2002.
Throughout the Ordinance for the words "University Grants Commission", the words "Higher Education Commission" shall be substituted.
11. The Indus Valley School of Arts and Architecture at Karachi Act, 1994.
In section 13-
(i) in sub-section (1), in clause (d), for the words and comma "Chairman, University Grants Commission", the words and comma "Chairperson, Higher Education Commission" shall be substituted.

- (ii) in sub-section (2), for the words "Chairman of the University Grants Commission", the words "Chairperson, Higher Education Commission" shall be substituted.
12. The Shaheed Zulfikar Ali Bhutto Institute of Science and Technology Act, 1995. In section 15, in sub-section (1), in clause (h), for the words and comma "Chairman, University Grants Commission", the words and comma "Chairperson, Higher Education Commission" shall be substituted.
13. The Institute of Business Management Act, 1996.
- 1) in section 2, in sub-section (1)-
 a) after clause (e), the following new clause shall be inserted:-
 "(ee, "Commission" means, the Higher Education Commission);"
 (ii) clause (w), shall be omitted.
- 2) in section 13, in sub-section (1), in clause (ii), for the words "Chairman of the Commission", the words "Chairperson, Higher Education Commission" shall be substituted.
- 3) In section 16, in sub-section (1), in clause (d), for the words "Chairman of the Commission", the words "Chairperson, Higher Education Commission" shall be substituted.
14. The Karachi Institute of Economics and Technology Ordinance, 2000.
- 1) In section 13, in sub-section (1), in clause (d), for the words and comma "Chairman, University Grants Commission", the words and comma "Chairperson, Higher Education Commission" shall be substituted.
- 2) In section 17, in sub-section (1), in clause (j), for the words "University Grants Commission", the words "Higher Education Commission" shall be substituted.

(the Sindh (Textile Institute of Pakistan) Ordinance, 2001.

In section 11, in sub-section (1), in clause (v), and in section 16, in sub-section (2), in clause (iv), for the words "University Grants Commission", the words "Higher Education Commission" shall be substituted.

16. The Khadim Ali Shah Bukhari Institute of Technology Ordinance, 2001.

1) In section 4 and in section 17, in sub-section (1), in clause (v), for the words "University Grants Commission", the words "Higher Education Commission" shall be substituted.

2) In section 14, in sub-section (1), in clause (v), for the words and comma "Chairman, University Grants Commission", the words and comma "Chairperson, Higher Education Commission" shall be substituted.

17. The Preston Institute of Management, Science and Technology Ordinance, 2001.

1) In section 4 and in section 19, in sub-section (1), in clause (vi), for the words "University Grants Commission", the words "Higher Education Commission" shall be substituted.

2) In section 16, in sub-section (1), in clause (iv), for the words and comma "Chairman, University Grants Commission", the words and comma "Chairperson, Higher Education Commission" shall be substituted.

18. The Newspapers Institute of Communications and Economics Ordinance, 2002.

- 1) In section 2 in clause (e) for the words "the University Grants Commission", the words "the Higher Education Commission" shall be substituted.
- 2) In section 8, in clause (a), in sub-clause (viii) and in para 10 of the First Statutes for the words "Commission", the words "Higher Education Commission" shall be substituted.
- 3) In section 13, in clause (a), in sub-clause (iii), for the words "Chairman of the Commission", the words "Chairperson, Higher Education Commission" shall be substituted.
