Karachi, the 7th March, 1994

No. PAS/Legis-B-10/93.—The Sugar Factories Control (Sindh Amendment) Bill, 1993 having been passed by the Provincial Assembly of Sindh on 26th December, 1993 and assented to by the Governor of Sindh on 2nd February, 1994 is hereby published as an Act of the Legislature of Sindh.

(First published after having received the assent of the Governor of Sindh in the Gazette of Sindh (Extra-Ordinary) dated 7th March, 1994).

ACT

*to amend the Sugar Factories Control Act, 1950, as applicable to Sindh.*

WHEREAS it is expedient to amend the Sugar Factories Control Preamble, Act, 1950, as applicable to Sindh, in the manner hereinafter appearing:

It is hereby enacted as follows:—

1. (1) This Act may be called the Sugar Factories Control (Sindh Amendment) Act, 1993.

(2) It shall come in to force at once.

2. In the Sugar Factories Control Act, 1950, as applicable to Sindh, hereinafter referred to as the said Act, the word "Provincial" wherever occurring shall be deleted.

3. In the said Act, in section 2—

- (i) in clause (e), the words "and who is not a Member of a Cane and Growers "Cooperative Society", shall be deleted,
- (ii) clause (f), shall be deleted;
- (iii) in clause (h), for the figure and the word "30th June", the figure and the word "15th April", shall be substituted;
- (iv) in clause (i), the words "by means of vacuum pans", shall be deleted;
- (v) after clause (i), the following new clause shall be inserted:—  
"i-a) "Government" means the Government of Sindh";
- (vi) clause (m) shall be deleted.

4. In the said Act, in section 8, in the proviso, between the word "Start" and the word "crushing" the words "and close" shall be inserted:

5. In the said Act, in section 10, in sub-section (2) for the words "Commissioner of the Division" the word Government shall be substituted.

6. In the said Act, in section 12, for the words "and Cane Grower's Cooperative Societies" shall be deleted.

7. In the said Act, in section 13—

- (i) sub-section (1), shall be deleted;
- (ii) for sub-section (2), the following shall be substituted:—  
" (2) the occupier of a Factory for which an area is reserved shall enter into an agreement with the cane-grower to purchase Cane in such form, on such terms and conditions and on such date as may be prescribed".
- (iii) in sub-section (3), the words "by a purchasing agent or" shall be deleted;



(iv) for sub-section (4), the following shall be substituted:—

“(4) the cane grown in a reserve area shall not be sole by any person other than a cane-grower”.

8. In the said Act, in section 14—

(i) for sub-section (ii), the following shall be substituted:—

“(ii) The occupier of a Factory, for which an area has been assigned, shall enter into an agreement with cane-growers in the assigned area for the purchase in the assigned area of such quantity of cane in such form, on such terms and conditions and by such date may be prescribed.”:

(ii) sub-section (iii), (iv) and (v) shall be deleted;

(iii) for section (vi), the following shall be substituted:—

“(iv) An appeal against an order under sub-section (I) shall lie to the Government.”.

9. In the said Act, in section 14-A, the words “or Cane-Growers Cooperative Societies” shall be deleted.

(ii) in the proviso, the words “or through a carrier”, shall be deleted.

“(iii) The occupier of a Factory shall not make any deduction from the amount due for cane sold to him by a Cane-grower except such deductions as may be prescribed or as the Government may, by notification, from time to time, allow.”.

(ii) the words “or Cane-Growers” Co-operative Society”, shall be deleted.

12. In the said Act, for section 17, the following shall be substituted:

“17. No person or class of persons shall be employed by an occupier of a Factory to do any work or class of work in connection with any transaction for the purchase of cane”.

13. In the said Act, in section 18, in sub-section (i), the words “or the members of Cane-Growers, Co-operative Societies”, shall be deleted.

14. In the said Act, in section 21, for the words "fifteen thousand" the words "one lac", shall be substituted.

(ii) in sub-section (ii), the words "or the Collector" shall be deleted;

(iii) in sub-section (iv), in clause (c), for the words 'any officer not below the status of a Collector', the words "the Cane Commissioner", shall be substituted.

16. In the said Act, in section 23, in sub-section (4), for the words "Sections 8 and (14)(v)", the words "section 8 ", shall be substituted.
