further to amend the Sind Employees Special Allowance (Payment) Act, 1986.

WHEREAS it is expedient to amend the Sind Employees Special Preamble. Allowance (Payment) Act, 1986, in the manner hereinafter appearing;

It is hereby enacted as follows:-

1. (1) This Act may be called the Sindh Employees Special Short title and comm-Allowance (Payment) (Amendment) Act, 1991. encement.

(2) It shall come into force at once and shall be deemed to have taken effect on and from 1st day of December, 1990.

Amendment in Sind Act X of 1986.

2. In the Sind Employees Special Allowance (Payment) Act, 1986, hereinafter referred to as the said Act, after the words "special allowance" wherever occurring except in section 3, the words "and additional special allowance" shall be added.

Insertion of section 3-A of Sind Act X of 1986.

- 3. In the said Act, after section 3, the following new section 3-A shall be added:-
 - "3-A. Every employee, irrespective of wages being paid to him, shall, invespect of his employment on or after the 1st day of December, 1990 be paid by his employer an additional special allowance equal to two hundred rupees per month."

4. The Sindh, Employees Special Allowance (Payment) (Amendment) Ordinance, 1991, is hereby repealed.
