## PART IV PROVINCIAL ASSEMBLY OF SINDH NOTIFICATION

Karachi, the 8th July, 1990.

No. PAS/Legis-B-3/90.—The Sindh Finance Bill, 1990 having been passed by the Provincial Assembly of Sindh on 24th June, 1990 and assented to by the Governor of Sindh on 2nd July, 1990 is hereby published as an Act of the Legislature of Sindh.

THE SINDH FINANCE ACT, 1990

SINDH ACT No. IV OF 1990

(First published after having received the assent of the Governor of Sindh in the Gazette of Sindh (Extra-Ordinary) dated 8th July, 1990).

AN

ACT

*to rationalize, enhance and levy certain duties and fees in the Province of Sindh.*

WHEREAS it is expedient to rationalize, enhance and levy certain duties and fees in the Province of Sindh;

It is hereby enacted as follows:—

Short title  
and commence-  
ment.

1. (1) This Act may be called the Sindh Finance Act, 1990.
- (2) It shall come into force on and from the 1st day of July, 1990.

Definitions

2. In this Act, unless there is anything repugnant in the subject or context—

- (a) "Government" means the Government of Sindh;
- (b) "prescribed" means prescribed by rules;
- (c) "rules" means rules made under this Act.

of 1860.

3. In the Societies Registration Act, 1860, in its application to the Province of Sindh—

- (i) in section 3, for the words "fifty rupees", the words "one thousand and five hundred rupees" shall be substituted;
- (ii) in section 19, for the words "One rupee", the words "two hundred rupees" and for the words "two annas" the words "ten rupees" shall be substituted.

Amendment  
of Act VII  
of 1870.

4. In the Court-Fees Act, 1870, in its application to the Province of Sindh, in the First Schedule, in Article 1—

- (a) in clause (iii), in column 3, for the words "exceeds thirty thousand rupees", the words "exceeds thirty thousand rupees but does not exceed six lac rupees" shall be substituted;
- (b) after clause (iii), amended as aforesaid, the following clause shall be added:—
- ((iv) exceeds six lac rupees. seven and a half percentum of the first thousand, five percentum of the next twenty-nine thousand rupees, two and a half percentum of the next five lac and seventy thousand rupees and two percentum of the remaining value.

5. In the Stamp Act, 1899 in its application to the Province of Sindh in Schedule I:— Amendment of Act II of 1899.

(1) after Article 22, the following new Article shall be inserted:—

“22-A. CONTRACT, that is to say, any instrument in the nature of memorandum or agreement made or entered into by a contractor with Government, Corporation, local body, local authority, agency or organization setup or controlled by the Federal or Provincial Government—

(a) to execute any work--

(b) to procure stores and materials; Twenty five paisa for every hundred rupees or part thereof of the amount of the contract.”

(2) in Article 23—

- (a) in clause (a), in column 2, for the words “Eight rupees”, the words “Nine rupees” shall be substituted;
- (b) in clause (b), in column 2, for the words “six rupees”, the words “seven rupees” shall be substituted;

✓ (3) in Article 28, in column 2, for the words "One rupee", the words "five rupees" shall be substituted;

(4) in Article 47 -

(1) in para A -

✓ (a) in sub-para 1, in clauses (i) and (ii), in column 2, for the words "Ten paisa", the words "Thirty paisa" and for the words "Five paisa" the words "Fifteen paisa" shall be substituted;

(b) in sub-para 2 -

(i) in clause (i), in column 2, for the words "Thirty paisa", the words "Ninety paisa" and for the words "Fifteen paisa", the words "Forty-Five paisa" shall be substituted;

✓ (ii) in clause (ii), in column 2, for the words "Sixty paisa" the words "One rupee and eighty paisa" and for the words "Thirty paisa", the words "Ninety paisa" shall be substituted;

(2) in para B, in sub-para (1):—

(a) in clause (i), in column 2, for the words "Fifty paisa", the words "One rupee and Fifty paisa" shall be substituted;

(b) in clause (ii), in column 2, for the words "One rupee" the words "Three rupees" shall be substituted;

(3) in para C -

(a) in clause (a), in column 2, for the words "Five paisa", the words "Fifteen paisa" shall be substituted;

(b) in clause (b), in column 2, for the words "Twenty Five paisa", the words "Seventy Five paisa" shall be substituted;

(4) in para D, in column 2, for the words "Five paisa" the words "Fifteen paisa" shall be substituted.

(5) in para E -

(a) in clause (i), in column 2, for the words "Ten paisa", the words "Thirty paisa" and for the words "Five paisa", the words "Fifteen paisa" shall be substituted;

(b) in clause (ii), in column 2, for the words "Twenty paisa", the words "Sixty paisa" and for the words "Ten paisa", the words "Thirty paisa" shall be substituted;

(c) in clause (iii), in column 2, for the words "Forty paisa", the words "One rupee and twenty paisa" and for the words "Twenty paisa", the words "Sixty paisa" shall be substituted.

6. The Court Fees (Sind Amendment) Ordinance, 1977, is hereby repealed. Repeal of  
Sind Ordinance XVII of  
1977.

7. In the Court Fees (Sind Amendment) Ordinance, 1978, for the words "Twenty-five thousand rupees", the words "fifty thousand rupees" shall be substituted. Amendment  
of Sind

XIII of 1978.

8. (1) No person shall engage in or carry on the business of a video film dealer, who deals in purchase or sale of, or lends on hire, video films, except under a licence. Licence for  
Video Film  
Dealer.

(2) The licence under sub-section (1) shall be issued by such authority in such form or renewed on such terms and conditions as may be prescribed on payment of the fees mentioned in the Schedule.

9. Whoever contravenes the provisions of section 8 shall be liable to pay in addition to licence fees a penalty not exceeding the amount of such fees. Penalty

10. No suit shall lie in any Civil Court to set aside fee levied under this Act and the rules thereunder or any penalty imposed under section 9. Bar of suits  
in Civil Court

11 Government may make rules for carrying into effect the purposes of this Act. Power to  
make rules.
