Karachi, the 5th June, 1991.

No. PAS/Legis-B-6/91.—The Sindh Ministers (Salaries, Allowances and Privileges) (Amendment) Bill, 1991 having been passed by the Provincial Assembly of Sindh on 28th April, 1991 and assented to by the Governor of Sindh on 30th May, 1991 is hereby published as an Act of the Legislature of Sindh.

THE SINDH MINISTERS (SALARIES, ALLOWANCES AND PRIVILEGES) (AMENDMENT) ACT, 1991

SINDH ACT No. III OF 1991

(First published after having received the assent of the Governor of Sindh in the Gazette of Sindh (Extra-Ordinary) dated 5th June, 1991).

AN

ACT

to amend the Sind Ministers (Salaries, Allowances and Privileges) Act, 1975.

WHEREAS it is expedient to amend the Sind Ministers (Salaries, Allowances and Privileges) Act, 1975, in the manner hereinafter appearing: Preamble.

It is hereby enacted as follows:—

Short title and commencement.

1. (1) This Act may be called the Sindh Ministers (Salaries, Allowances and Privileges) (Amendment) Act, 1991.

(2) It shall come into force at once.

Amendment of section 6-A of Sind Act, VIII of 1975.

2. In the Sind Ministers (Salaries, Allowances and Privileges) Act, 1975, hereinafter referred to as the said Act, in section 6-A, for sub-section (1) the following shall be substituted:—

“(1) A Minister may in his discretion make grants to the extent of one hundred thousand rupees in a year.”

Amendment of section 10 of Sind Act, VIII of 1975.

3. In the said Act, in section 10, in sub-section (1), for the words “one hundred and twenty five rupees”, the words “one hundred and fifty rupees” shall be substituted.

Insertion of section 10-A in Sind Act, VIII of 1975.

4. In the said Act, after section 13, the following new section shall be added:—

Payment of actual expenses.

“13-A. Where a Minister, while travelling on duty outside the Province, stays in a hotel, guest-house, inspection bungalow, lodge or a residential club shall, in addition to the daily allowance admissible under section 10, be entitled to the reimbursement of the actual single room rent not exceeding three times of the daily allowance, per day, on production of receipts/vouchers.”
