No. PAS/Legis-B-5/91.—The Sindh Finance (Amendment) Bill, 1991 having been passed by the Provincial Assembly of Sindh on 9th May, 1991 and assented to by the Governor of Sindh on 4th June, 1991 is hereby published as an Act of the Legislature of Sindh.

THE SINDH FINANCE (AMENDMENT)
ACT, 1991

SINDH ACT NO. V OF 1991

(First published after having received the assent of the Governor of Sindh in the Gazette of Sindh (Extra-Ordinary) dated 13th June, 1991).

AN

ACT

to amend the Sind Finance Act, 1964, and the Sind Finance Act, 1975,

WHEREAS it is expedient to amend the Sind Finance Act, 1964 and the Sind Finance Act, 1975, in the manner hereinafter appearing. Preamble

It is hereby enacted as follows:—

1. (1) This Act may be called the Sindh Finance (Amendment) Act, 1991.

(2) It shall come into force at once.

2. In the Sind Finance Act, 1964, in section 12—

(i) after sub-section (2), the following new sub-section shall be added:—

“(2-A) There shall be levied a surcharge on the cess payable under sub-section (1) at the rate of fifteen paise per 40 Kilograms to meet the expenses in connection with the water supply and drainage schemes undertaken by the Councils constituted under the Sind Local Government Ordinance, 1979.”;

(ii) in sub-section (3), between the word “cess” and the word “payable”, the words “and the surcharge” shall be inserted.

Amendment
of section 8
of Sind
Act, XV of
1975.

3. In the Sind Finance Act, 1975, in section 8—

(i) after sub-section (1), the following new sub-section shall be inserted:—

“(1-A) There shall be levied a surcharge on the fee payable under sub-section (1) at the rate of fifty paise per 100 Kilograms to meet the expenses in connection with the water supply and drainage schemes undertaken by the Councils.”;

(ii) in sub-section (2), for the words and figures “The fee under sub-section (1)” the words “The fee and the surcharge” shall be substituted;

(iii) in sub-section (3), for the words “The fee and” the words and comma “The fee, surcharge and” shall be substituted.

4. The Sindh Finance (Amendment) Ordinance, 1991 is hereby repealed.
