SINDH ORDINANCE NO. I OF 2002

AN
ORDINANCE

WHEREAS it is expedient to amend the Sindh Local Government Ordinance, 2001, in the manner hereinafter appearing;

Preamble.

AND WHEREAS the Provincial Assembly stands dissolved in pursuance of the Proclamation of the fourteenth day of October, 1999 and the Provisional Constitution Order No. 1 of 1999;

AND WHEREAS the Governor of Sindh is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in pursuance of the aforesaid Proclamation and the Provisional Constitution Order read with Provisional Constitution (Amendment) Order No.9 of 1999, and in exercise of all powers enabling him in that behalf, the Governor of Sindh is pleased to make and promulgate the following Ordinance:-

Short title and commencement.

1. (1) This Ordinance may be called the Sindh Local Government (Third Amendment) Ordinance, 2001.
- (2) It shall come into force at once and shall be deemed to have taken effect on and from 14th August, 2001.

Amendment of section 28 of Sindh Ordinance No. XXVII of 2001.

2. In the Sindh Local Government Ordinance, 2001, hereinafter referred to as the said Ordinance, in section 28, in sub-section (2), in clause (e), for the words "City District", the words "City District Government" shall be substituted.

3. In the said Ordinance, in section 112, in sub-section (2), for the words "ten weeks", the words "as soon as possible but not later than the date fixed by Government" shall be substituted.

Amendment of section 112 of Sindh Ordinance No. XXVII of 2001.

4. In the said Ordinance, in the first Schedule, in Part-A, in clause (viii), after the word "forest", the words "excluding water shed management and natural forests, guzara forests & protected forests", shall be added.

Amendment of first Schedule to Sindh Ordinance No. XXVII of 2001.

5. In the said Ordinance, in the Fifth Schedule, in Part-1 (Rules), clause 2 shall be omitted.

Amendment of Schedule to Sindh Ordinance No. XXVII of 2001.
