Sindh Ordinance No. XXVI of 2002

AN
ORDINANCE

to amend the Sindh Board of Technical
Education Ordinance, 1970.

WHEREAS it is expedient to amend the Sindh Preamble

Board of Technical Education Ordinance, 1970, in the manner hereinafter appearing;

AND WHEREAS the Provincial Assembly stands dissolved in pursuance of the Proclamation of the fourteenth day of October, 1999, and the Provisional Constitution Order No.1 of 1999;

AND WHEREAS the Governor of Sindh is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in pursuance of the aforesaid Proclamation and the Provisional Constitution Order read with Provisional Constitution (Amendment) Order No.9 of 1999, and in exercise of all powers enabling him in that behalf, the Governor of Sindh is pleased to make and promulgate the following Ordinance:-

Short title and commencement. (1) This Ordinance may be called the Sindh Board of Technical Education (Amendment) Ordinance, 2002.

(2) It shall come into force at once.

Short title and commencement. 1. (1) This Ordinance may be called the Sindh Board of Technical Education (Amendment) Ordinance, 2002.

(2) It shall come into force at once.

2. In the Sindh Board of Technical Education Ordinance, 1970, for section 10, the following shall be substituted:-

Amendment of section 10 of Sindh Ordinance XVI of 1970.

"10. The Governor of Sindh shall be the Controlling Authority of the Board."
