Short title and commence ment.

- 1. (1) This Ordinace may be called the Sindh Land Revenue (Abolition) Ordinance, 2000.
 - (2) It shall come into force at once.

Definitions 2.

- (ii) "land revenue" means the land revenue as defined in the Act.
