

### AN ORDINANCE

to amend the Sindh Private Medical Education Institutions (Regulation and Control) Ordinance, 2001.

WHEREAS it is expedient to amend the Sindh Private Preamble. Medical Education Institutions (Regulation and Control) Ordinance, 2001 in the manner hereinafter appearing;

AND WHEREAS the Provincial Assembly stands suspended in pursuance of the Proclamation of the fourteenth day of October, 1999, and the Provisional Constitution Order No.1 of 1999;

AND WHEREAS the Governor of Sindh is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in pursuance of the aforesaid. Proclamation and the Provisional Constitution Order read with Provisional Constitution (Amendment) Order No.9 of 1999, and in exercise of all powers enabling him in that behalf, the Governor of Sindh is pleased to make and promulgate the following Ordinance:

Short title and commencement.

- 1. (1) This Ordinance may be called the Sindh Private Medical Education Institutions (Regulation and Control) (Amendment) Ordinance, 2001.
  - (2) It shall come into force at once.

Amendment of long. title of Sindh Ordinance No V of 2001. 2. In the Sindh Private Medical Education Institutions (Regulation and Control) Ordinance, 2001, in the long title for the words "certain institutions" the words "the institutions imparting medical education" shall be substituted and shall be deemed always to have been so substituted.
