THE SIND CIVIL SERVANTS WELFARE FUND (AMENDMENT) ORDINANCE, 1984.

Sind Ordinance No. XIV of 1984.

AN

ORDINANCE

to amend the Sind Civil Servants Welfare Fund Ordinance, 1979.

WHEREAS it is expedient to amend the Sind Civil Servants Welfare Fund Ordinance, 1979, in the manner hereinafter appearing; Preamble.

NOW, THEREFORE, in pursuance of the Proclamation of the fifth day of July, 1977 and the Provisional Constitution Order, 1981, the Governor of Sind is pleased to make and promulgate the following Ordinance:—

1. (1) This Ordinance may be called the Sind Civil Servants Welfare Fund (Amendment) Ordinance, 1984. Short title and commencement.
- (2) It shall come into force at once and shall be deemed to have taken effect on and from the 1st day of July, 1983.

2. In the Sind Civil Servants Welfare Fund Ordinance, 1979 hereinafter referred to as the said Ordinance, in section 1, in sub-section (3), the words "grade or", shall be omitted.

3. In the said Ordinance, in section 2—

(i) for clause (a), the following shall be substituted:—

"(a) "basic scale" means a basic scale of pay sanctioned by Government in which a post or group of posts is placed;

(aa) "civil servant" means a civil servant as defined in the Sind Civil Servants Act, 1973;"

(ii) clause (e) shall be omitted.

4. In the said Ordinance, in section 3, for the word "grade" wherever occurring, the words "basic scale" shall be substituted.

(b) for the word "grades" wherever occurring, the words "basic scales" shall be substituted.
