SIND ORDINANCE NO. XII OF 1983

AN

ORDINANCE

to amend the Sindh Local Government Ordinance, 1979.

WHEREAS it is expedient to amend the Sindh Local Government Preamble Ordinance, 1979, in the manner hereinafter appearing:

NOW, THEREFORE, in pursuance of the Proclamation of the fifth day of July, 1977 and the Provisional Constitution Order, 1981, the Governor of Sindh is pleased to make and promulgate the following Ordinance:—

1. (1) This Ordinance may be called the Sindh Local Government (Fourth Amendment) Ordinance, 1983.

Short title and commencement.

(2) It shall come into force at once.

2. In the Sind Local Government Ordinance, 1979, in section 39, in sub-section (4), for the words "and mutatis mutandis be dealt with in accordance with that law", the words "and be tried in summary way in accordance with the procedure laid down in sections 262 to 265 of the Code of Criminal Procedure, 1898." shall be substituted. Amendm. of section 39 of Sind Ord. XIII of 1979

SIND ORDINANCE NO. XV OF 1981

AN

ORDINANCE

to amend the Sindh Local Government Ordinance, 1979.

WHEREAS it is expedient to amend the Sindh Local Government Preamble Ordinance, 1979, in the manner hereinafter appearing;

NOW, THEREFORE, in pursuance of the Proclamation of the fifth day of July, 1977 and the Provisional Constitution Order, 1981, the Governor of Sindh is pleased to make and promulgate the following Ordinance:—

1. (1) This Ordinance may be called the Sindh Local Government (Fourth Amendment) Ordinance, 1981.

(2) It shall come into force at once.

2. In the *Sind Local Government Ordinance, 1979*, hereinafter referred to as the said Ordinance, for section 15, the following shall be substituted:—

Composition
of Taluka
Council.

15. A taluka council shall consist of—

- (a) the Chairmen of the Union Councils in the Taluka;
- (b) the members of the District Council elected from the Taluka;
- (c) two women elected by women members of the Union Councils in the Taluka from amongst themselves.”

3. In the said Ordinance, in section 37, in sub-section (2), in clause (c), the words “under the Pakistan Penal Code” shall be omitted and be deemed to have always been so omitted.

4. In the said Ordinance, in section 60, in sub-section (4), for the word “Government” the words “the order sanctioning such levy or contribution” shall be substituted and be deemed to have always been so substituted.

5. In the said Ordinance, in Schedule II, in Part II, in paragraph 40 of OPTIONAL FUNCTIONS, clauses (1) and (2) shall be omitted.

6. In the said Ordinance, in Schedule V, in Part III, for clause (6), the following clause shall be substituted:—

“6. Toll on the export of goods to be called Rawangi Mahsool by District Councils only, and may be shared by the District Council with such Councils of the District and in such ratio as and when directed by Government.”
