No. S.Legis.1(2)/82.—The following Ordinance by the Governor of Sind is hereby published for general information:—

### THE SIND UNIVERSITIES LAWS (AMENDMENT) ORDINANCE, 1982.

SIND ORDINANCE NO. II OF 1982

AN

ORDINANCE

*To amend the enactments relating to Universities in Sind.*

WHEREAS it is expedient to amend the enactments relating to Universities, in the manner here-in-after appearing;

NOW, THEREFORE, in pursuance of the Proclamation of the fifth day of July, 1977 and the provisional Constitution Order, 1981, the Governor of Sind is pleased to make and promulgate the following Ordinance:—

Preamble.

1. (1) This Ordinance may be called the Sind Universities Laws (Amendment) Ordinance, 1982.

Short title and commencement.

(2) It shall come into force at once.

2. In the University of Sind Act, 1972 and the University of Karachi Act, 1972—

Amendment of sections 14 and 23 of Sind Acts XXIV and XXV of 1972.

(a) in section 14, in sub-section (4), for clause (ix), the following shall be substituted:—

“(ix) to make appointments to the posts in all grades of the National Scales of pay upto grade 16”; and

(b) in section 23, in sub-section (2), for clause (r), the following shall be substituted:—

“(r) to make appointments on the recommendation of the Selection Board to the posts in grades 17 and above of the National Scales of Pay;”.

3. In the N.E.D. University of Engineering and Technology Act, 1977 and the Mehran University of Engineering and Technology Act, 1977—

(a) in section 16, in sub-section (2), in clause (m), for the words “carrying initial pay exceeding five hundred rupees”, the words and figures “in grades 17 and above of the National scales of Pay” shall be substituted; and

(b) in section 28, in clause (vi), for the words “carrying initial pay not exceeding five hundred rupees per month”, the words and figures “in all grades of the National Scales of pay upto grade 16” shall be substituted.

4. In the Sind Agriculture University Act, 1977—

(a) in section 16, in sub-section (2), in clause (k), for the words “carrying initial pay exceeding five hundred rupees”, the words and figures “in grades 17 and above of the National scales of pay” shall be substituted; and

(b) in section 28, in clause (vi), for the words “carrying initial pay not exceeding five hundred rupees per month”, the words and figures “in all grades of the National scales of pay upto grade 16” shall be substituted.
