THE SIND LOCAL GOVERNMENT (SECOND AMENDMENT)
ORDINANCE, 1982.

SIND ORDINANCE NO. XIII OF 1982

AN

ORDINANCE

to amend the Sind Local Government Ordinance, 1979.

WHEREAS it is expedient to amend the Sind Local Government Preamble Ordinance, 1979, in the manner hereafter appearing;

NOW, THEREFORE, in pursuance of the Proclamation of the fifth day of July, 1977 and the Provisional Constitution Order, 1981, the Governor of Sind, is pleased to make and promulgate the following Ordinance:—

Short title
and com-
mencement.

1. (1) This Ordinance may be called the Sind Local Government (Second Amendment) Ordinance, 1982.

(2) It shall come into force at once.

2. In the Sind Local Government Ordinance, 1979, hereinafter referred to as the said Ordinance, in section 3—

(i) in clause (9), for the words "or Chief Officer" the commas and the words ", Chief Officer, Town Officer or Secretary" shall be substituted;

(ii) in clause (15), the comma and the words ", taluka council" shall be omitted;

(iii) in clause (20), for the words "and 'divisional co-ordination committee' ", the comma and the words ", 'divisional co-ordination committee' and 'taluka co-ordination committee' " shall be substituted;

(iv) in clause (63), the words "taluka council or" shall be omitted;

(v) clause 68 shall be omitted;

(vi) in clause (79), for the words "district council or", the words and commas "union council, district council, town committee or" shall be substituted.

3. In the said Ordinance, in section 6, the comma and the word ", taluka" shall be omitted.

Amendment
of section 10
of Sind

XII of 1979.

4. In the said Ordinance, in section 10—

(i) in sub-section (1), in clause (b), sub-clause (ii) shall be omitted;

(ii) in sub-section (2), the words "or taluka council" shall be omitted;

(iii) after sub-section (2), the following shall be inserted:—

"(2-A) If a member nominated under sub-section (2)—

(a) is guilty of abuse of power or misconduct or has acted or is acting in contravention of the provisions of this Ordinance, rules or bye-laws, he may, after he has been afforded an opportunity of being heard, be removed by the council; or

(b) absents himself, without reasonable excuse, from three consecutive meetings of the panchayat, he shall cease to be the member of the panchayat."

5. In the said Ordinance, in section 14, in sub-section (1), the words "other than taluka council" shall be omitted. Amendment of section 14 of Sind Ordinance XII of 1979.
6. In the said Ordinance, section 15 shall be omitted. Omission of section 15 of Sind Ordinance XII of 1979.
7. In the said Ordinance, in section 21, for sub-section (1), the following shall be substituted:— Amendment of section 21 of Sind Ordinance XII of 1979.
- “(1) A member may resign his office by tendering resignation in writing to the Chief Executive and his seat shall become vacant forthwith.”
8. In the said Ordinance, in section 26, for sub-section (1), the following shall be substituted:— Amendment of section 26 of Sind Ordinance XII of 1979.
- “(1) A Mayor, Deputy Mayor, Chairman or Vice-Chairman may resign his office by tendering resignation in writing to the Chief Executive and his seat shall become vacant forthwith.”
9. In the said Ordinance, in section 40, sub-sections (2) and (3) shall be omitted. Amendment of section 40 of Sind Ordinance XII of 1979.
10. In the said Ordinance, in section 50, in sub-section (1), the words "taluka council and" shall be omitted. Amendment of section 50 of Sind Ordinance XII of 1979.
11. In the said Ordinance, in section 68, in sub-section (1), clause (e) shall be omitted. Amendment of section 68 of Sind Ordinance XII of 1979.
12. In the said Ordinance, for section 89, the following shall be substituted:— Amendment of section 89 of Sind Ordinance XII of 1979.
- “89. (1) Government may set up a divisional, district or taluka co-ordination committee in a division, district or taluka respectively.
- Divisional, district and taluka co-ordination committees.
- (2) A divisional, district or taluka co-ordination committee shall consist of such number of members from urban and rural areas of the division, district or, as the case may be, the taluka, as may be fixed by Government.
- (3) The Chairman, Vice-Chairman and members of a divisional, district or taluka co-ordination committee shall be elected or appointed in the prescribed manner.”

13. In the said Ordinance, for section 90, the following shall be substituted:—

“90. The divisional, district or taluka co-ordination committee shall co-ordinate the activities of all councils and all nation Functions building departments in the division, district or taluka, as the case may be, and may perform such other functions as may be assigned to them by Government for the furtherance of the purposes of this Ordinance.”

Amendment
of section 91
of Sind
Ordinance
XII of 1979.

14. In the said Ordinance, in section 91, in sub-section (1), for clause (a), the following shall be substituted:—

“(a) to the Taluka Co-ordination Committee, if the parties concerned are in the same taluka;

(aa) to the District Co-ordination Committee, if the parties concerned are in different talukas in the same District;”

Sind Ordinance XII of
1979.

15. In the said Ordinance, in section 102-F, before the fullstop, the words “or less than fifty rupees” shall be inserted.
