Karachi, the 16th March, 1974

No. PAS/Legis./B-5/74.—The Sind Board of Technical Education (Amendment) Bill, 1974 having been passed by the Provincial Assembly of Sind on the 8th March, 1974 and assented to by the Governor of Sind on the 16th March, 1974 is hereby published as an Act of the Legislature of Sind:—

THE SIND BOARD OF TECHNICAL EDUCATION (AMENDMENT) ACT, 1974.

SIND ACT No. II OF 1974.

(First published after having received the assent of the Governor of Sind in the Gazette of Sind (Extra Ordinary) dated 16th March, 1974).

AN

ACT

to amend the Sind Board of Technical Education Ordinance, 1970.

WHEREAS it is expedient to amend the Sind Board of Technical Education Ordinance, 1970, in the manner hereinafter appearing; Preamble.

It is hereby enacted as follows:—

Short title
and com-
mencement.

1. (1) This Act may be called the Sind Board of Technical Education (Amendment) Act, 1974.

(2) It shall come into force at once.

2. In the Sind Board of Technical Education Ordinance, 1970, hereinafter referred to as the Principal Ordinance, in sub-section (1) of section 4—

(a) in clause (iii), for the words "Sind Engineering College", the words "Sind University Engineering College" shall be substituted;

(b) for clause (v) the following clause shall be substituted:—

"(v) the Chairman, Board of Intermediate Education, Karachi and the Chairman, Board of Secondary Education, Karachi;"

(c) in clause (vii), for the words and comma "Education Extension and Specialized Services Sind, Hyderabad", the words and commas "Bureau of Curriculum, Education Extension and Specialized Services, Sind", shall be substituted;

(d) in clause (ix), (x) and (xi), for the word "Government", the words "Controlling Authority" shall be substituted;

(e) in clause (xi), the word "and" shall be omitted;

(f) for clause (xii), the following clause shall be substituted:—

"(xii) one Industrialist to be nominated by the Controlling Authority;" and

(g) after clause (xii), the following clauses (xiii) and (xiv) shall be added:—

"(xiii) one member of Central Council, Institute of Engineers Pakistan, belonging to any local centre of the Institute in Sind, to be nominated by the Controlling Authority; and

(xiv) the Deputy Director of Vocational Institutes for Girls, Directorate of Technical Education, Sind."

3. In the Principal Ordinance, in section 7, for the figure "5", the figure "4" shall be substituted.

4. In the Principal Ordinance, in section 10, for the word "Secretary", the word "Minister" shall be substituted.

5. In the Principal Ordinance, in sub-section (2) of section 12, at the end of clause (i), omit semi colon and add the following:—

“and also to regulate the development of technical, vocational, industrial and commercial education below degree level by compulsory registration thereof;”

6. In the Principal Ordinance, in sub-section (1) of sections 16 and 17, for the word “Government”, the words “Controlling Authority” shall be substituted.

7. In the Principal Ordinance, after section 30, the following shall be added as section 31:—

“31. Anything done, proceeding or action taken, rights Saving or assets acquired, obligation or liability incurred, persons appointed or authorised, jurisdiction or power conferred, endowment, bequest or fund created, donation or grant made, scholarship or award instituted, recognition granted, order issued and Regulations or Rules made by the West Pakistan Board of Technical Education or any other Board in this behalf on or after 1st July, 1970 in relation to institutions in the Province of Sind shall be deemed to have been respectively done, taken, acquired, incurred, appointed or authorised, conferred, created, made, instituted, granted, issued and made by the Board constituted under this Ordinance.”

8. The Sind Board of Technical Education (Amendment) Ordinance, 1974, is hereby repealed.
