THE SIND BOARDS OF INTERMEDIATE AND SECONDARY
EDUCATION (AMENDMENT) ORDINANCE, 1978.

SIND ORDINANCE NO. XIV OF 1978.

AN

ORDINANCE

to amend the Sind Boards of Intermediate and Secondary Education Ordinance, 1972.

WHEREAS it is expedient to amend the Sind Boards of Intermediate and Secondary Education Ordinance, 1972, in the manner hereinafter appearing; Preamble.

NOW, THEREFORE, in pursuance of the proclamation of the fifth day of July, 1977, read with the Laws (Continuance in Force) Order, 1977, the Governor of Sindh is pleased to make and promulgate the following Ordinance:—

1. (1) This Ordinance may be called the Sind Boards of Intermediate and Secondary Education (Amendment) Ordinance, 1978.

(2) It shall come into force at once.

2. In the Sind Boards of Intermediate and Secondary Education Ordinance, 1972, hereinafter referred to as the said Ordinance, in section 2, for clause (u), the following shall be substituted:—

“(u) ‘University’ when used with reference to Boards in Karachi means the University of Karachi, and when used with reference to the Boards at other places means the University of Sind.”

3. In the said Ordinance, in section 3, in sub-section (1)—

- (i) in clause (a), the word “and” occurring at the end of sub-clause (ii) shall be deleted;
- (ii) in clause (b), the fullstop occurring at the end shall be replaced by a semi-colon and the word “;and”;
- (iii) after clause (b), the following clause (c) shall be added:—

“(c) at Sukkur, a Board called the Board of Intermediate and Secondary Education, Sukkur.”

of Sind Or-
dinance VI
of 1972.

4. In the said Ordinance, in section 4, in sub-section (1); in clause (iii)—

- (i) in sub-clause (b), the word “and” shall be deleted;
- (ii) in sub-clause (c), the full-stop occurring at the end shall be replaced by a semi-colon and the word “;and”;
- (iii) after sub-clause (c), the following sub-clause (d) shall be added:—

“(d) the Board of Intermediate and Secondary Education, Sukkur, the Directors of School Education and College Education.”

5. In the said Ordinance, in the Schedule, for the word “Hyderabad”, wherever occurring, the words “Hyderabad or Sukkur” shall be substituted.
