### NOTIFICATION

Karachi, the 24th June, 1974

No. PAS/Legis/Bill-14/74.—The West Pakistan Entertainments Duty (Sind Amendment) Bill, 1974 having been passed by the Provincial Assembly on the 12th June, 1974 and assented to by the Governor of Sind on the 21st June, 1974 is hereby published as an Act of the Legislature of Sind:—

### THE WEST PAKISTAN ENTERTAINMENTS DUTY (SIND AMENDMENT) ACT, 1974

SIND ACT NO. XI OF 1974

(First published after having received the assent of the Governor of Sind in the Gazette of Sind (Extra-Ordinary) dated 24th June, 1974).

AN

ACT

*to further amend the West Pakistan Entertainments Duty Act, 1958, in its application to the Province of Sind.*

WHEREAS it is expedient to further amend the West Pakistan Entertainments Duty Act, 1958, in its application to the Province of Sind, in the manner hereinafter appearing; Preamble.

It is hereby enacted as follows:—

1. (1) This Act may be called the West Pakistan Entertainments Duty (Sind Amendment) Act, 1974. Short title and commencement.

(2) It shall come into force at once.

2. In the West Pakistan Entertainments Duty Act, 1958, in its application to the Province of Sind, hereinafter referred to as the said Act, in section 2, clauses (aa), (aaa), (hh), (ii) and (k) shall be omitted.

3. In section 6 of the said Act, the words and commas "or in the case of any cinema, the entertainments duty is not paid in accordance with the provisions of section 6-A," shall be omitted.

4. Section 6-A of the said Act shall be omitted.

5. In section 11 of the said Act, in sub-section (2)—  
(a) at the end of clause (i), the word "and" shall be added; and  
(b) clauses (i-a), (i-b) and (i-c) shall be omitted.

6. The Schedule to the said Act shall be omitted.

Repeal of

7. The West Pakistan Entertainments Duty (Sind Amendment) Ordinance, 1974, is hereby repealed.
