

PROVINCIAL ASSEMBLY OF SIND

NOTIFICATION

Karachi, dated the 28th June, 1973.

No. PAS/Legis-B-8/73.—The Sind Industrial Trading Estate Recovery of Dues Bill, 1973 having been passed by the Provincial Assembly of Sind on the 6th June, 1973 and assented to by the Governor of Sind on the 27th June, 1973 is hereby published as an Act of the Legislature of Sind:—

THE SIND INDUSTRIAL TRADING ESTATE RECOVERY OF DUES ACT, 1973.

Sind Act No. VIII of 1973.

(First published after having received the assent of the Governor of Sind in the Gazette of Sind (Extra Ordinary) dated 28th June, 1973).

AN

ACT

to provide for recovery of the dues [of the Sind Industrial Trading Estate] as assets of public revenue

WHEREAS it is expedient to provide for ^{the} recovery of the ^{public dues} dues of the Preamble. Sind Industrial Trading Estate; *in the manner hereinafter appearing*

It is hereby enacted as follows:—

1. (1) This Act may be called the Sind ^{Public Dues} Industrial Trading Estate Recovery of Dues Act, 1973. *96*

Short title extent and commencement.

(2) It extends to the whole Province of Sind.

(3) It shall come into force at once.

2. In this Act, unless the context otherwise requires, the following expressions shall have the meanings hereby respectively assigned to them, that is to say—

Definitions.

(a) "defaulter" means a person from whom any dues are recoverable by the Sind Industrial Trading Estate and includes a person who is responsible as surety for payment of any such dues;

(b) "Government" means the Government of Sind; and

(c) "Sind Industrial Trading Estate" means the Sind Industrial Trading Estate Company created under Sind Government Resolution No. 24-I.B/47-1, dated 2nd June, 1947.

Declaration
of dues.

3. (1) Government may by notification declare that any dues or class of dues recoverable by Sind Industrial Trading Estate shall be recoverable from defaulters as if such dues were the arrears of land-revenue.

(2) On publication of the notification under sub-section (1) any such dues shall be recoverable under the Revenue Recovery Act, 1890 (Act I of 1890) as arrears of land-revenue.

Power to
make rules.

4. Government may make rules for the purposes of giving effect to the provisions of this Act.

Repeal of
Sind Ordinance VII of
1973.

5. The Sind Industrial Trading Estate Recovery of Dues Ordinance, 1973, is hereby repealed.
