No. PAS/Legis-B-7/72.—The West Pakistan Land Revenue (Sind Amendment) Bill, 1972 having been passed by the Provincial Assembly of Sind on the 5th July, 1972 and assented to by the Governor of Sind on 17th July, 1972 is hereby published as an Act of the Provincial Legislature of Sind:—

THE WEST PAKISTAN LAND REVENUE (SIND AMENDMENT) ACT, 1972.

SIND ACT No. 9 OF 1972.

(First published, after having received the assent of the Governor of Sind in the Gazette of Sind (Extra-Ordinary), dated 18th July, 1972).

ACT

to amend the West Pakistan Land Revenue Act, 1967, in its application to the Province of Sind.

WHEREAS it is expedient to amend the West Pakistan Preamble. Land Revenue Act, 1967, in its application to the Province of Sind.

It is hereby enacted as follows:-

- 1. This Act may be called the West Pakistan Land Revenue Short title. Sind Amendment) Act, 1972.
- 2. In the West Pakistan Land Revenue Act, 1967 (West amendment. Pakistan Act XVII of 1967), hereinafter referred to as the said Act, for the word "estate" wherever occurring the word "deh" shall be substituted.
 - 3. In section 4 of the said Act:-
 - (a) in clause (3) for the words "a group of estates" the words "a deh or group of dehs" shall be substituted; of west
 - (b) clause (16) shall be omitted;

- (c) after clause (19), the following shall be added as clause (19-A):—
 - "(19-A) produce index unit "means the measure in terms of which the comparative productivity of a particular land in a particular assessment circle or area is computed and expressed for the purpose of the scheme relating to the resettlement of displaced persons on land, and in respect of the assessment circle and areas where no such unit exists, such measure as may be determined by the Board of Revenue."

Amendment of section 56 of West Pakistan Act XVII of 1967.

- 4. In the said Act, in section 56—
 - (a) in clause (e) of sub-section (1) the words and figures "immediately before the date of notification of general assessment or re-assessment under section 56" shall be omitted;
 - (b) after clause (e) of sub-section (1) the following clause (f) shall be added:—
 - "(f) such class of holdings as may be prescribed by Government by notification in the Official Gazette",
 - (c) for sub-section (3) the following shall be substituted:-
 - "(3) Land Revenue may be assessed as a fixed annual charge payable in the lumpsum or by instalments, or in the form of a prescribed rate per produce index unit".

Amendment of section 57 of West Pakistan Act XVII of 1967.

- 5. In the said Act, for section 57 the following shall be substituted:-
 - "57-(1) Assessment of land revenue shall be based on the produce index units of the land concerned.
 - (2) The produce index units for the first five years shall be the produce index units recognized for the purpose

of settlement of displaced person on land, or where no such produce index units exist the produce index units as may be determined by the Board of Revenue

(3) The produce index units in relation to any land may be calculated and determined by such method as may be prescribed.

Provided that produce index units once determined shall not be changed within five years of such determination.

- (4) The amount of land revenue per produce index unit may, wherever necessary, be revised from time to time but no such revision shall take place within five years of the last revision".
- 6. In the said Act section 58 to 69 shall be omitted.
