Karachi, dated the 28th December, 1972.

No. PAS/Legis-B-22/72.—The West Pakistan Primary Education and Local Councils High Schools (Sind Amendment) Bill, 1972 having been passed by the Provincial Assembly of Sind on the 22nd December, 1972 and assented to by the Governor of Sind on the 28th December, 1972 is hereby published as an Act of the Legislature of Sind:—

THE WEST PAKISTAN PRIMARY EDUCATION AND LOCAL COUNCILS HIGH SCHOOLS (SIND AMENDMENT) ACT, 1972.

Sind Act No. XXII of 1972.

(First published after having received the assent of the Governor of Sind in the Gazette of Sind (Extra Ordinary) dated the 28th December, 1972).

AN

ACT

to amend the West Pakistan Primary Education Ordinance, 1962 and the West Pakistan Local Councils High School (Taking Over) Ordinance, 1970 in their application to the Province of Sind.

Preamble.

WHEREAS it is expedient to amend the West Pakistan Primary Education Ordinance, 1962 and the West Pakistan Local Councils High Schools (Taking Over) Ordinance, 1970;

It is hereby enacted as follows:—

Short title and commencement.

1. (1) This Act may be called the West Pakistan Primary Education and Local Councils High Schools (Sind Amendment) Act, 1972.

(2) It shall be deemed to have taken effect on and from the first day of October, 1972.

Amendment of Section 2 of West Pakistan Ordinance XXIX of 1962.

2. In the West Pakistan Primary Education Ordinance, 1962 (West Pakistan Ordinance XXIX of 1962), in section 2, in clause (g), the words "and includes a municipality or Municipal Corporation" shall be added before the semi-colon at the end.

Amendment of Section 2 of West Pakistan Ordinance XV of 1970.

3. In the West Pakistan Local Councils High Schools (Taking Over) Ordinance, 1970 (West Pakistan Ordinance XV of 1970), in section 2, in clause (g), the words "and includes a Municipality or Municipal Corporation" shall be added before the semi-colon at the end.

4. Any notification applying the West Pakistan Primary Education Ordinance, 1962 (West Pakistan Ordinance XXIX of 1962) or the West Pakistan Local Councils High Schools (Taking Over) Ordinance, 1970 (West Pakistan Ordinance XV of 1970) to any municipality or Municipal Corporation, may take effect from any date not prior to the 1st day of October, 1972.

Power to issue notifications retrospectively.

5. The West Pakistan Primary Education and Local Councils High Schools (Sind Amendment) Ordinance, 1972 is hereby repealed.

Repeal of Sind Ordinance XIX of 1972.
