NO.PAS/Legis-B-06/2012- The Sindh Laws (Second Amendment) Bill, 2012 having been passed by the Provincial Assembly of Sindh on 8th March, 2013 and assented to by the Governor of Sindh on 12th March, 2013 is hereby published as an Act of the Legislature of Sindh.

SINDH ACT NO. XXII OF 2013.

AN

to amend certain laws in force in the Province of Sindh.

WHEREAS It is expedient to amend certain laws in force in Preamble. the Province of Sindh;

It is hereby enacted as follows:-

- (1) This Act may be called the Sindh Laws (Second Amendment) Act, 2012.

 Short title and Commencement.
 - (2) It shall come into force at once and shall be deemed to have taken effect on and from 5th November, 2011.
- In laws specified in column 2 of the Schedule below are hereby amended to the extent and in the manner specified against them in column 3 thereof.

- (a) after clause (13), the following new clause shall be inserted:-
 - "(14) "Collector" shall mean the Chief Officer incharge of the revenue administration of a District and shall include a Deputy Commissioner;";
- (b) after clause (16), the following new clause shall be inserted
 - "(17) "Commissioner" shall mean the Chief Officer of the revenue and general administration of a division, and shall include an Additional Commissioner;"; and
- (c) in clause (19), for the words "District Officer (Revenue)", the word "Collector" shall be substituted.

 - The Sindh Rural Credit 1. Throughout the Act, for the words "District Officer (Revenue)", the word "Collector" shall be substituted.
