NO.PAS/Legis-B-06/2012- The Sindh Laws (Second Amendment) Bill, 2012 having been passed by the Provincial Assembly of Sindh on 8<sup>th</sup> March, 2013 and assented to by the Governor of Sindh on 12<sup>th</sup> March, 2013 is hereby published as an Act of the Legislature of Sindh.

### THE SINDH LAWS (SECOND AMENDMENT) ACT, 2012.

### SINDH ACT NO. XXII OF 2013.

### AN ACT

to amend certain laws in force in the Province of Sindh.

**WHEREAS** It is expedient to amend certain laws in force in the Province of Sindh; **Preamble.**

It is hereby enacted as follows:-

- (1) This Act may be called the Sindh Laws (Second Amendment) Act, 2012. **Short title and Commencement.**
- (2) It shall come into force at once and shall be deemed to have taken effect on and from 5<sup>th</sup> November, 2011.

2. In laws specified in column 2 of the Schedule below are hereby amended to the extent and in the manner specified against them in column 3 thereof.
