NO.PAS/Legis-B-04/2009- The Sindh Assembly Members (Salaries and Allowances) (Amendment) Bill, 2009 having been passed by the Provincial Assembly of Sindh on 15th March, 2013 and assented to by the Governor of Sindh on 28th March, 2013 is hereby published as an Act of the Legislature of Sindh.

**THE SINDH ASSEMBLY MEMBERS (SALARIES AND
ALLOWANCES) (AMENDMENT) ACT, 2009.**

SINDH ACT NO. XXXIV OF 2013.

**AN
ACT**

to amend the Sindh Assembly Members (Salaries and Allowances) Act, 1974.

WHEREAS it is expedient to amend the Sindh Assembly Members (Salaries and Allowances) Act, 1974, in the manner hereinafter appearing;

Preamble.

It is hereby enacted as follows:-

- Short title and commencement.** 1. (1) This Act may be called the Sindh Assembly Members (Salaries and Allowances) (Amendment) Act, 2009.
- (2) It shall come into force at once and shall be deemed to have taken effect on and from 1st July, 2011.
- Amendment of Section 3 of the Sind Act No. XXVI of 1974.** 2. In the Sindh Assembly Members (Salaries and Allowances) Act, 1974, hereinafter referred to as the said Act, in section 3, for the words "fifteen thousand", the words "twenty four thousand" shall be substituted.
- Amendment of Section 3-A of the Sind Act No. XXVI of 1974.** 3. In the said Act, in section 3-A, for the words "three thousand", the words "four thousand eight hundred" shall be substituted.
- Amendment of Section 3-B of the Sind Act No. XXVI of 1974.** 4. In the said Act, in section 3-B, for the words "ten thousand" the words "sixteen thousand" shall be substituted.
- Amendment of Section 3-C of the Sind Act No. XXVI of 1974.** 5. In the said Act, in section 3-C, for the words "three thousand", the words "four thousand eight hundred", shall be substituted.
- Addition of Section 3-D of the Sind Act No. XXVI of 1974.** 6. In the said Act, after section 3-C, the following new Section shall be added:
- "3-D The salary and other emoluments shall automatically be increased by Government in proportion increase to be made in the salary of the civil servants in BPS-22, from time to time."
- Amendment of Section 4 of the Sind Act No. XXVI of 1974.** 7. In the said Act, in section 4, for the words "five hundred and fifty rupees", and for the words "four hundred rupees", the words "Eight hundred eighty rupees" and the words "six hundred forty rupees" shall respectively be substituted.
- Amendment of Section 4-B of the Sind Act No. XXVI of 1974.** 8. In the said Act, in section 4-B, for the words "one thousand and five hundred", the words "two thousand four hundred", shall be substituted.
- Amendment of Section 5 of the Sind Act No. XXVI of 1974.** 9. In the said Act, in section 5, in sub-section (1) in the proviso, for the words "three rupees", the words "twenty rupees" shall be substituted.
- Amendment of Section 5-A of the Sind Act No. XXVI of 1974.** 10. In the said Act, in section 5-A-
- (i) in sub-section (1), for the words "forty thousand rupees" the words "one hundred and twenty thousand rupees" shall be substituted; and
- (ii) in the sub-section (2), for the words "thirty thousand rupees bears to the sum of forty thousand rupees" the words "one hundred thousand rupees" shall be substituted.

11. In the said Act, in section 6, after sub-section (2), the following shall be added: **Amendment of Section 6 of the Sind Act No. XXVI of 1974.**
- "(3) A member shall be entitled to receive mobile phone charges at the rate of ten thousand rupees per month."
12. In the said Act, in section 6-B, for the words "five thousand" the words "eight thousand" shall be substituted. **Amendment of Section 6-B of the Sind Act No. XXVI of 1974.**
