NO.PAS/Legis-B-01/2011- The Sindh Fisheries (Amendment) Bill, 2011 having been passed by the Provincial Assembly of Sindh on 13th January, 2011 and assented to by the Governor of Sindh on 17th February, 2011 is hereby published as an Act of the Legislature of Sindh.

THE SINDH FISHERIES (AMENDMENT) ACT, 2011 SINDH ACT NO: V OF 2011

AN
ACT

to amend the Sind Fisheries Ordinance, 1980.

WHEREAS it is expedient to amend the Sind Fisheries Ordinance, 1980, in the manner hereinafter appearing; **Preamble.**

It is hereby enacted as follows:-

1. (1) This Act may be called the Sindh Fisheries (Amendment) Act, 2011.

**Short title and
Commencement.**

- (2) It shall come into force at once.
2. In the Sind Fisheries Ordinance, 1980, hereinafter referred to as the said Ordinance, throughout the Ordinance, for the word "Sind", the word "Sindh" shall be substituted. **Amendment of Sind Ordinance No.III of 1980.**
3. In the said Ordinance, in section 2 - **Amendment of section 2 of Sind Ordinance No.III of 1980.**
- (i) after clause (c), the following shall be added :-
 "(c-i) "Fisherman" means a person who earns his livelihood by catching fish from All Public Water Bodies and whose primary source of income is the money which he earns by selling such fish;"
- (ii) in clause (g), after the word "canal", the words "and all other fishing water bodies" shall be added;"
- (iii) clause (i) shall be deleted.
4. In the said Ordinance, for section 3, the following shall be substituted :- **Amendment of section 3 of Sind Ordinance No.III of 1980.**
- "3. Power to issue licences for fishing and fish trade.** (1) Government may, by general or special order, grant licence for fishing in any public waters on such terms and conditions and on payment of such fees as may be prescribed.
- (2) All the leases granted prior to the commencement of this section shall stand cancelled."
5. In the said Ordinance, in section 27, in sub-section (2), clause (o) shall be deleted. **Amendment of section 27 of Sind Ordinance No.III of 1980.**
