NOTIFICATION

Karachi, the 20th February, 1994

No. PAS/Legis-B-16/93.—The Sindh Laws (Amending and Repealing) Bill, 1993 having been passed by the Provincial Assembly of Sindh on 27th December, 1993 and assented to by the Governor of Sindh on 2nd February, 1994 is hereby published as an Act of the Legislature of Sindh.

THE SINDH LAWS (AMENDING AND REPEALING) ACT, 1993.

SINDH ACT No.. II OF 1994

(First Published after having received the assent of the Governor of Sindh in the Gazette of Sindh (Extra-Ordinary) dated 20th February, 1994).

AN

ACT

to amend and repeal certain laws in force in the Province of Sindh.

WHEREAS it is expedient to amend and repeal certain laws which are spent or have become un-necessary or ceased to be in force otherwise than by express repeal; Preamble

It is hereby enacted as follows:—

Short title
and commen-
cement.

1. (1) This Act may be called the Sindh Laws (Amending and Repealing) Act, 1993.

(2) It shall come into force at once.

2. In the Good Conduct Prisoners' Probational Release Act, 1926, as applicable to Sindh, in section 1, in sub-section (2), the comma and the words, "except Karachi" shall be deleted as if these had never been included in that sub-section.

3. In the Agricultural Produce Markets Act, 1939, as applicable to Sindh—

(i) in section 6, in sub-section (5), for the words "Bureau of Supply and Prices" the words "Agriculture Extension", shall be substituted;

(ii) in section 8, in sub-section (3)—

(a) in clause (a), for the word "nine", the word "ten", shall be substituted;

(b) in clause (b), the word "sixteen", the word "eighteen", shall be substituted;

(iii) in section, 27, in sub-section (2), in clause (XXVIII), the word "People's", shall be deleted.

4. In the Sind Deti Leti Act, 1939, in section 12, in sub-section (1) for the word "Crown", the word "State", shall be substituted.

5. In the Soil Reclamation Act, 1952, as applicable to Sindh, in section 4, in sub-section (1), in clause (c), the words "West Pakistan" shall be deleted.

6. In the Sindh Children Act, 1955—

(i) in section 20, sub-section (2), shall be deleted;

(ii) in section 97, for the figure "1929", the figure "1955", shall be substituted;

(iii) section 99 and proviso thereunder, shall be deleted.

1955.

7. In the Sindh Cultural Advancement Board Act, 1955—

(i) in section 13, in clause (vi), for the words, comma and figure "Sind People's Local Government Ordinance 1972", the words, comma and figure "Sind Local Government Ordinance, 1979", shall be substituted;

(ii) in section 17, 29 and in the Schedule, the word "People's", shall be deleted.

Repeal. 8. The laws specified in Schedule to this Act are hereby repealed:—

Repeal of Sindh Ordinance No. xx of 1993 9. The Sindh Laws (Amending and Repealing) Ordinance, 1993 is hereby repealed.
