AN
ORDINANCE

*to adapt and revise the existing laws applicable to the Province of
Sind.*

WHEREAS it is expedient to adapt and revise the existing laws applicable to the Province of Sind, repeal some of them, and to make declarations in respect of certain laws to facilitate the preparation of the Sind Code;

AND WHEREAS the Legislature of the Province is not in session and the Governor of Sind is satisfied that circumstances exist which render it necessary for him to take immediate action;

AND WHEREAS instructions of the Governor-General have been obtained;

NOW, THEREFORE, in exercise of the powers conferred upon him by section 88 of the Government of India Act, 1935, the Governor of Sind is pleased to promulgate the following Ordinance:—

Short title
and com-
mencement.

1. (1) This Ordinance may be called the Sind Laws (Adaptation, Revision, Repeal and Declaration) Ordinance, 1955.

(2) It shall come into force at once.

(3) Sections 3, 4 and 11 shall be deemed to have taken effect on the 30th day of May, 1951.

2. In this Ordinance "existing law" means any Act, Ordinance, Regulation, Rule, Bye-law or Form which immediately before the promulgation of this Ordinance has the force of law in the Province of Sind and shall include the local Acts and Regulations of the Governor-General in Council but shall not include any Act of the Central Legislature with respect to any of the matters enumerated in List I of the seventh schedule to the Government of India Act, 1935.

3. In the existing laws unless otherwise directed by this Ordinance—

(i) for the word "Bombay" in the short and long titles or preamble or in a citation or description of an enactment, the word "Sind" shall be substituted;

(a) Repeals of, omissions from, additions to and modification of any existing laws made under the said Ord. shall be deemed to have been made under the said Act, s.e.f. 14.10.55.
(b) in para 2 of the Schedule to the Sind Medical Councils Act, the word "India" shall not be deemed to have been replaced by Sind.
(c) in the "Sind Code" the word "Bombay" shall be deemed to be "Sind".

(ii) for the words—

(a) "Bombay Presidency" and "Presidency of Bombay" the words "Province of Sind";

(b) "India" and "British India" the word "Pakistan"; and

(c) "Presidency" the word "Province" shall be substituted; and

(iii) in Sind Acts amending Bombay Acts—

(a) the expressions "in its application to the Province of Sind", "in its application to Sind" or "in their application to the Province of Sind" wherever occurring shall be omitted; and

(b) in the short titles, the word "Sind" within brackets shall be omitted.

4. The short title of any Central Act referred to in any existing law shall be amended in accordance with the Adaptation of Central Acts and Ordinances Order, 1949.

5. The Acts, Ordinances and Regulations specified in the First Schedule are hereby wholly repealed.

6. The Acts and Regulations specified in the Second Schedule are hereby repealed to the extent mentioned in the fourth column thereof.

7. The Acts and Regulations specified in the Third Schedule are hereby amended to the extent and in the manner mentioned in the fourth column thereof.

8. The Acts and Regulations specified in the Fourth Schedule are hereby declared to be no part of the laws of the Province of Sind.

I of
1951.</sup> and the notification No. 51-L/49/I, dated 30th May, 1951, issued thereunder is cancelled.

12. Any appointment, notification, order, scheme, rule, form or bye-law made or issued under any existing law by an authority for which a new corresponding authority has been substituted by or under this Ordinance, shall be deemed to have been made or issued by such new authority unless and until superseded by an appointment, notification, order, scheme, rule, form or bye-law made or issued by such new authority.

Wherever an expression mentioned in the first column of the table hereunder printed occurs in any existing law, whether mentioned in the schedules to this Ordinance or not, then, unless otherwise provided by this Ordinance or unless the context otherwise provides, there shall be substituted therefor the expression set opposite to it in column 2 of the said table:—
