NO.PAS/Legis-B-20/2013- The Gambat Institute of Medical Sciences (Amendment) Bill, 2013 having been passed by the Provincial Assembly of Sindh on 20<sup>th</sup> September, 2013 and assented to by the Governor of Sindh on 30<sup>th</sup> October, 2013 is hereby published as an Act of the Legislature of Sindh.

THE GAMBAT INSTITUTE OF MEDICAL SCIENCES (AMENDMENT) ACT, 2013.

SINDH ACT NO. XLVI OF 2013.

ACT

to amend the Gambat Institute of Medical Sciences Act, 2005.

WHEREAS it is expedient to amend the Preamble. Gambat Institute of Medical Sciences Act, 2005, in the manner hereinafter appearing;

It is hereby enacted as follows:-

- (1) This Act may be called the Gambat Institute of Medical Sciences (Amendment) Act, 2013.
  - (2) It shall come into force at once.

In the Gambat Institute of Medical Sciences Act, Amendment of 2005, hereinafter referred to as the said Act, in section section 3 of Sind 3, after sub-section (2) the following new sub-section Act No.V of shall be added:-

2006.

- "(3) The Gambat Institute of Medical Sciences shall be an independent degree awarding institute.".
- In the said Act, in section 5, after sub-section Amendment of (1), the following new sub-section shall be inserted:-

section 5 of Sind Act No.V of 2006.

"(i-a) to hold examinations and to award and confer degrees, diplomas, certificates and other academic distinctions to and on the persons who have been admitted to and have passed its examination under the prescribed conditions.".

In the said Act, in section 7, in sub-section (1), Amendment of Sindh Act No.V of 2006.

for the word "Governor", the words "Chief Minister" section 7 of shall be substituted.

> section 7 of Sindh Act No.V of 2006.

In the said Act, in section 8, in sub-section (1), Amendment of for clause (iv), the following shall be substituted:-

"(iv) Chairman, Municipal Committee Gambat

Member".

The provisions of the Shaheed Mohtarma Benazir Repeal. Bhutto Medical University Larkana Act, 2008 (Act No.VI of 2008) relating to the Gambat Institute of Medical Sciences are hereby repealed.
