NO.PAS/Legis-B-20/2013- The Gambat Institute of Medical Sciences (Amendment) Bill, 2013 having been passed by the Provincial Assembly of Sindh on 20th September, 2013 and assented to by the Governor of Sindh on 30th October, 2013 is hereby published as an Act of the Legislature of Sindh.

(AMENDMENT) ACT, 2013.**

SINDH ACT NO. XLVI OF 2013.

**AN
ACT**

to amend the Gambat Institute of Medical Sciences Act, 2005.

WHEREAS it is expedient to amend the Preamble. Gambat Institute of Medical Sciences Act, 2005, in the manner hereinafter appearing;

It is hereby enacted as follows:-

1. (1) This Act may be called the Gambat Institute of Medical Sciences (Amendment) Act, 2013. **Short title and commencement.**
- (2) It shall come into force at once.

2. In the Gambat Institute of Medical Sciences Act, 2005, hereinafter referred to as the said Act, in section 3, after sub-section (2) the following new sub-section shall be added:-
- Amendment of section 3 of Sind Act No.V of 2006.**

"(3) The Gambat Institute of Medical Sciences shall be an independent degree awarding institute."

3. In the said Act, in section 5, after sub-section (1), the following new sub-section shall be inserted:-
- Amendment of section 5 of Sind Act No.V of 2006.**

"(i-a) to hold examinations and to award and confer degrees, diplomas, certificates and other academic distinctions to and on the persons who have been admitted to and have passed its examination under the prescribed conditions."

4. In the said Act, in section 7, in sub-section (1), for the word "Governor", the words "Chief Minister" shall be substituted.
- Amendment of section 7 of Sindh Act No.V of 2006.**

5. In the said Act, in section 8, in sub-section (1), for clause (iv), the following shall be substituted:-
- Amendment of section 7 of Sindh Act No.V of 2006.**

"(iv) Chairman, Municipal
Committee Gambat Member"

6. The provisions of the Shaheed Mohtarma Benazir Bhutto Medical University Larkana Act, 2008 (Act No.VI of 2008) relating to the Gambat Institute of Medical Sciences are hereby repealed.
