THE LAND ACQUISITION (WEST PAKISTAN AMENDMENT) (REPEAL) ORDINANCE, 1971.

SIND ORDINANCE NO. VI OF 1971.

AN

ORDINANCE

to repeal the Land Acquisition (West Pakistan Amendment) Act, 1969.

WHEREAS it is expedient to provide for the repeal of the Land Acquisition (West Pakistan Amendment) Act, 1969 (W.P. Act III of 1969), and the amendments effected thereby in the Land Acquisition Act, 1894 (Act I of 1894);

NOW, THEREFORE, in pursuance of the Martial Law Proclamation of 25th March, 1969, read with the Provisional Constitution Order, and in exercise of all powers enabling him in that behalf, the Governor of Sind and Martial Law Administrator, Zone 'D', is pleased to make and promulgate the following Ordinance:-

1. This Ordinance may be called the Land Acquisition (West Pakistan Amendment) (Repeal) Ordinance, 1971.

2. The Land Acquisition (West Pakistan Amendment) Act, 1969, is hereby repealed and shall be deemed never to have been enacted, and the III of 1969. amendments effected thereby in the Land Acquisition Act, 1894 (Act I of 1894), shall be deemed never to have been effected.

Payment of interest on compensation.

Where a court has directed payment of interest on any amount of compensation payable under the Land Acquisition Act, 1894 (Act I of 1894), at a rate exceeding six per centum simple interest per annum, interest shall be payable on such amount, notwithstanding any judgment, decree or order of the court, at six per centum simple interest per annum.
