NO.PAS/Legis-B-06/2016-The Karachi Development Authority (Revival and Amending) Bill, 2016 having been passed by the Provincial Assembly of Sindh on 21st March, 2016 and assented to by the Governor of Sindh on 9th May, 2016 is hereby published as an Act of the Legislature of Sindh.

**AN
ACT**

to revive and amend the law relating to the Karachi Development Authority.

WHEREAS in order to give impetus and encourage the housing industry and provide shelter to the people of the Province, it is expedient to revive and amend the law relating to the Karachi Development Authority. **Preamble.**

It is hereby enacted as follows:-

- 1.(1) This Act may be called the Karachi Development Authority (Revival and Amending) Act, 2016. **Short title and commencement.**
- (2) It shall come into force at once.
2. The Karachi Development Authority Order, 1957, shall stand revived on and from 1st day of July, 2002, as if it had never been repealed and on revival, the said **Revival of Order V of 1957.**

Order shall stand amended to the extent and in the manner hereinafter appearing.

3. In the said Order, in Article 5 -

(i) for clause (1), the following shall be substituted:-

"(1) **Constitution of the Governing Body.**- The Governing Body shall consist of-

- (a) Minister, Local Government, Housing Town Planning Department **Chairman**
- (b) Two Members of the Provincial Assembly to be nominated by Government **Member**
- (c) Secretary, Local Government and Housing Town Planning Department **Member**
- (d) Commissioner, Karachi **Member**
- (e) Director General, Karachi Development Authority **Member/Secretary**
- (f) Member Technical, Karachi Development Authority **Member**
- (g) Member Finance Karachi Development Authority **Member**
- (h) Member (Admn), Karachi Development Authority **Member**

(ii) clauses (2) and (3) shall be omitted.

4. All orders made, proceedings taken, appointments, made, acts done by any authority, or by any person, which were made, taken or done, or purported to have been made, taken or done between the first day of July, two thousand two, and the date on which this Act comes into force (both days inclusive), shall, notwithstanding any judgment of any court, be deemed to be and always to have been validly made, taken or done under the Karachi Development Authority Order, 1957 and shall not be called in question in any court or forum on any ground whatsoever. **Saving.**
