NO.PAS/LEGIS-B-39/2015-The Provincial Motor Vehicles (Amendment) Bill, 2015 having been passed by the Provincial Assembly of Sindh on 2nd February, 2017 and assented to by the Governor of Sindh on 15th March, 2017 is hereby published as an Act of the Legislature of Sindh.

THE PROVINCIAL MOTOR VEHICLES (AMENDMENT) ACT, 2015.
SINDH ACT NO. V OF 2017.

AN

to amend the Provincial Motor Vehicles Ordinance, 1965.

WHEREAS it is expedient to further amend the Preamble. Provincial Motor Vehicles Ordinance, 1965, in the manner hereinafter appearing;

It is hereby enacted as follows:-

- 1. (1) This Act may be called the Provincial Motor Vehicles

 (Amendment) Act, 2015.

 Short title and commencement.
 - (2) It shall come into force at once.

Amendment of section 49 of the West Pakistan Ordinance No.XIX of 1965.

- 2. In the Provincial Motor Vehicles Ordinance, 1965, hereinafter referred to as the said Ordinance, in section 49
 - (i) in sub-section (1), for the words "a bank guarantee", the words "a certificate of Group Insurance issued by an Insurance Company, duly registered with the Securities and Exchange Commission of Pakistan and approved and notified in the official Gazette by Government" shall be substituted:
 - (ii) for sub-section (2), the following shall be substituted:-
 - "(2) No certificate, as contemplated by subsection (1) shall be required in respect of a stage carriage permit authorizing the plying of a stage carriage exclusively in an urban area.
 - (3) In case the certificate, as required under sub-section (1), is withdrawn by the Insurance Company, the permit shall stand cancelled.
 - (4) The permits issued before the coming into force of this amendment shall not remain valid after the expiry of 45 days of the coming into force of this amendment, if the certificate, as required by sub-section (1), is not filed with the Regional Transport Authority within the stipulated time.

Amendment of section 67-F of the West Pakistan Ordinance No.XIX of 1965.

- 3. In the said Ordinance, in section 67-F -
 - (a) in sub-section (1)-
 - (i) in clauses (a), for the words "a bank guarantee", and "the guarantee" wherever appearing, the words "the certificate" and for the words "the bank giving the guarantee", the words "the Insurance Company issuing the certificate" shall be substituted respectively; and
 - (ii) In clause (b), for the words "a bank guarantee", the words "the certificate" shall be substituted;
 - (b) in sub-section (2), for the words "a fresh bank guarantee", the words "the fresh certificate" shall be substituted.

4. In the said Ordinance, 1965, for the Thirteenth Substitution of the Schedule, the following shall be substituted:-
