PROVINCIAL ASSEMBLY OF SINDH NOTIFICATION KARACHI, THE 12TH APRIL, 2017

NO.PAS/LEGIS-B-07/2017-The Jacobabad Institute of Medical Sciences (Amendment) Bill, 2017 having been passed by the Provincial Assembly of Sindh on 29th March, 2017 and assented to by the Governor of Sindh on 08th April, 2017 is hereby published as an Act of the Legislature of Sindh.

THE JACOBABAD INSTITUTE OF MEDICAL SCIENCES (AMENDMENT) ACT, 2017.

SINDH ACT NO. IX OF 2017.

to amend the Jacobabad Institute of Medical Sciences Act, 2013.

WHEREAS it is expedient to amend the Jacobabad Institute of Preamble. Medical Sciences Act, 2013, in the matter hereinafter appearing;

It is hereby enacted as follows:-

- 1. (1) This Act may be called Jacobabad Institute of Medical Sciences Shore title and (Amendment) Act, 2017. Commencement.
 - (2) It shall come into force at once.
- In the Jacobabad Institute of Medical Sciences Act, 2013, Amendment of hereinafter referred to as the said Act, in section 3, for sub-section section 3 of (1), the following shall be substituted:-

Sindh Act No. XIX of 2013.

"(1) An Institute to be called Jacobabad Institute of Medical Sciences shall be established at Jacobabad.".

Omission of section 4 of Sindh Act No.XIX of 2013. In the said Act, section 4 shall be omitted.

Amendment of section 5 of Sindh Act No.XIX of 2013.

In the said Act in Section 5, after clause (vi), the following shall be inserted:-

"(vi-i) to confer or award degrees, diplomas, certificates, and other academic distinctions on and to persons, who have passed its examination under prescribed conditions.

(vi-ii) to affiliate with any University and disaffiliate medical institutions and inspect colleges and other educational institutions affiliated or seeking affiliation with it."

Amendment of section 7 of Sindh Act No. XIX of 2013.

In the said Act, in section 7, in sub-section (1), for the word "Governor", the words "Chief Minister" shall be substituted.

Amendment of section 8 of Sindh Act No.XIX of 2013.

- In the said Act, in section 8, for sub-section (1), the following shall be substituted:-
- "(1) The general direction and administration of the Institute and its affairs shall vest in the Board consisting of the following:-
- (i) Minister Health or if there is no Minister Chairman Health, Member of Cabinet nominated by Government

(ii) Secretary Health. -

Vice

(iii) Four members of Provincial Assembly Sindh nominated by Speaker Sindh Assembly

Chairman Member

(iv) Secretary Finance or his nominee not below Member the rank of BS-19.

(v) Registrar Shaheed Benazir Bhutto Medical Member University Larkana

(vi) Commissioner Larkana Division in his Member absence Deputy Commissioner, Jacobabad

Professional having (vii) substantial Member contribution to the field of Medical Sciences recognized nationally and internationally (nominated by Government)

(viii) A member of judiciary nominated by Chief Member Justice, High Court of Sindh

(ix) Director Institute of Business Administration Member

Registrar College of Physician and Surgeons Member of Pakistan (CPSP)

President Chamber of Commerce Jacobabad Member

Two reputed citizens from adjacent area of Members (xii) Jacobabad involved in philanthropy activities nominated by Government.

(xiii) Special Secretary Health Department

Member

(xiv) Officer Commanding or his representative of Pakistan Air Force Shahbaz Base Jacobabad not below the rank of Group Captain.

In the said Act, in section 9, in sub-section (2), after clause Amendment of (viii), the following shall be inserted:-

section 9 in Sindh Act No. XIX of 2013.

"(ix) to enter into an agreement with private sector entities, for out sourcing the management and service delivery of the whole or part of Institute.".

8 In the said Act, in section 10 -

Amendment of section 10 in Sindh Act No.

X!X of 2013.

- (i) for sub-section (1), the following shall be substituted:-
 - "(1) The Board shall meet at least once in a quarter with the gap of at least three months on the dates to be fixed by the Director in consultation with the Chairman.".
- (ii) after sub-section (6), the following shall be added:-
 - "(7) The office of a nominated member shall become vacant if he resigns or fails to attend three consecutive meetings of the Board without sufficient cause or leave of absence".
- In the said Act, in section 11, the following proviso shall be Amendment of omitted.

"Provided that the person holding office of the Medical XIX of 2013. Superintendent of the District Headquarter Jacobabad immediately before the commencement of this Act shall be the first Director of the Institute.".

Amendment of 10. In the said Act, in section 13, for sub-section (2), the section 13 of following shall be substituted:

Sindh Act No. XIX of 2013.

"(2) The Academic Council shall consist of the Professors and Associate Professors of the Institute, who shall elect the Chairman from amongst themselves for a period of two years, and a student representative nominated by the Academic Council.".
