NO.PAS/LEGIS-B-15/2017- The Sindh Laws (Amendment) Bill, 2017 having been passed by the Provincial Assembly of Sindh on 18th May, 2017 and assented to by the Governor of Sindh on 19th June, 2017 is hereby published as an Act of the Legislature of Sindh.

THE SINDH LAWS (AMENDMENT) ACT, 2017.

SINDH ACT NO. XXII OF 2017.

ACT

to amend certain laws in force in the Province of Sindh.

WHEREAS it is expedient to amend certain laws in force in Preamble. the Province of Sindh;

It is hereby enacted as follows:-

- 1. (1) This Act may be called the Sindh Laws (Amendment) Act, Short title and 2017.
  - Commencement.
  - (2) It shall come into force at once and shall be deemed to have taken effect on and from 1st day of July, 2016.

2. In laws specified in column 2 of the Schedule below are hereby amended to the extent and in the manner specified against them in column 3 thereof.

  1. In section 3, for the words "twenty four thousand", the words "fifty thousand" shall be substituted.
  - 2. In section 3-A, for the words "four thousand eight hundred", the words "ten thousand" shall be substituted.
  - 3. In section 3-B, for the words "sixteen thousand rupees", the words "forty five thousand" shall be substituted.
  - 4. In section 3-C, for the words "four thousand eight hundred", the words "fifteen thousand" shall be substituted.
  - 5. In section 4, for the words "eight hundred eighty rupees" and for, the words "six hundred forty rupees", the words "one thousand rupees" shall be respectively be substituted.
  - 6. In section 4-B, for the words "two thousand four hundred rupees", the words "five thousand" shall be substituted.
  - 7. In section 5-A -
    - (i) in sub-section (1), for the words "one hundred and twenty thousand rupees", the words "two hundred thousand rupees" shall be substituted;
    - (ii) in sub-section (2), for the words "one hundred thousand rupees", the words "one hundred and fifty thousand rupees" shall be substituted.
  - 8. In section 6, in sub-section (1), for the words "five thousand", the words "ten thousand" shall be substituted.
  - In section 6-B, for the words "eight thousand", the words "fifteen thousand" shall be substituted.

- Compensation in case of Air or Road Accident Rs. 50,00,000/= for Member of the Provincial Assembly of Sindh.
- The Sindh Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) Act, 1975(Act No. VII of 1975).
- 1. In section 3-A, for the words "seven thousand", the words "fifty thousand" shall be substituted.
- In section 5, in sub-section (1), for the words "eight thousand and seventy thousand", the words "one hundred fifty thousand and one hundred forty thousand" shall respectively be substituted.
- 3. In section 6, in sub-section (2), for the words "fifty five thousand three hundred" and the words "forty nine thousand", the words "seventy thousand" and the words "sixty thousand" shall respectively be substituted.
- 4. In section 7-A, for the words "five hundred thousand rupees and three hundred thousand rupees", the words "ten hundred thousand rupees and five hundred thousand rupees" shall respectively be substituted.
- In section 8, for the words eight thousand four hundred", the words "twenty thousand" shall be substituted.
- In section 10, for the words "seven hundred and seventy", the words "two thousand" and "one thousand and five hundred" shall be substituted.
- 7. Residence Maintenance Allowance (Instead of Furnishing Government/ Private Residence)
  Rs. 70,000/= for Speaker and Rs. 50,000/= for Deputy Speaker respectively per month.
- 8. Compensation in case of Air or Road Accident Rs. 50,00,000/= for Speaker and the Deputy Speaker respectively.
- 3. The Sindh Ministers (Salaries, Allowances and Privileges Act, 1975 (Act No. VIII of 1975).
  - The Sindh Ministers 1. In section 3-A, for the words "fifteen thousand rupees," Allowances and Privileges Act, "twenty thousand rupees," shall be substituted.
    - For section 5, the following shall be substituted:-
      - "5. **Salary.** The salary of the Chief Minister and a Minister shall respectively be one hundred fifty thousand rupees and seventy five thousand rupees per mensem.

- In section 6, for the words "thirteen thousand rupees and nine thousand rupees", the words twenty thousand rupees" shall be substituted.
- 4. For 6-A, the following shall be substituted:-
  - "6-A. **Discretionary Grant.** An appropriate amount and a sum of ten hundred thousand rupees in a year shall be placed at the disposal of the Chief Minister and five hundred thousand rupees at the disposal of Minister per annum for making discretionary grants in such manner as may be prescribed.
- 5. In section 7, in sub-section (2), for the words "thirty nine thousand", the words "fifty five thousand" shall be substituted.
- 6. In section 10, for the words "five hundred and fifty rupees", the words "twenty thousand rupees and one thousand five hundred rupees respectively" shall be substituted.
- 7. Residence Maintenance Allowance (Instead of Furnishing Government/ Private Residence)
  Rs. 70,000/= for Chief Minister and Rs. 50, 000/= for Minister respectively per month.
- 8. Compensation in case of Air or Road Accident Rs. 50,00,000/= for Chief Minister and the Minister respectively.
- 4. The Sindh Special
  Assistants
  (Appointment,
  Powers, Functions,
  Salaries, Allowances
  and Privileges) Act,
  2003 (Act No.I of
  2005).
- In section 5, for the words "seventeen thousand", the words "seventy thousand" shall be substituted.
- 2. In section 6, for the words "four thousand", the words "ten thousand" shall be substituted.
- 3. In section 8 -
  - (i) in sub-section (2), for the words "fifteen thousand", the words "thirty thousand" shall be substituted;
  - (ii) after sub-section (2), the following new sub-section shall be added:-
    - "(3) Where the Special Assistant is not provided with an official residence or prefers to reside in his own house or a private residence, he shall be paid forty five thousand rupees per mensem."

- 4. After section 8, the following new section shall be inserted:-
  - "8-A **Equipment Allowance.** The Special Assistant to Chief Minister, on his first appointment, as such, receive an equipment allowance of fifty thousand rupees."
- 5. After sectopm 9, the following new section shall be inserted:-
- "9-A. Daily Allowance of duration halts.
  (1). The Special Assistant, during the tour on official duty, be entitled to draw a daily allowance of rupees one thousand for the duration of halts:

Provided that half Daily Allowance shall be admissible for the day arrival, the day of departure and the day of both arrival and departure.".

- 6. Residence Maintenance Allowance (Instead of Furnishing Government/ Private Residence) Rs. 30,000/= for Special Assistant to Chief Minister per month.
- 7. Compensation in case of Air or Road Accident Rs. 50,00,000/= for Special Assistant to Chief Minister
