No. PAS/Legis-B-14/89.—The Sindh Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) (Amendment) Bill, 1989 having been passed by the Provincial Assembly of Sindh on 29th November, 1989 and assented to by the Governor of Sindh on 19th December, 1989 is hereby published as an Act of the Legislature of Sindh.

(First published after having received the assent of the Governor of Sindh in the Gazette of Sindh (Extra-Ordinary) dated 31st December, 1989).

AN

ACT

*to amend the Sindh Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) Act, 1975.*

WHEREAS it is expedient to amend the Sindh Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) Act, 1975, in the manner hereinafter appearing;

1. (1) This Act may be called the Sindh Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) (Amendment) Act, 1989.

(2) It shall come into force at once.



2. In the Sind Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) Act, 1975, hereinafter referred to as the said Act, after section 7, the following new section shall be inserted:—

“7-A(1) The Speaker may in his discretion make grants to the Discretionary Grants extent of fifty thousand rupees in a year:

(2) The accounts of the grants shall be audited annually by the Accountant General, Sindh or his nominee.”

3. In the said Act, after section 8, the following new section shall be inserted:—

“8-A. The Speaker shall be entitled at the Government expense to the use of two telephones at his office and two telephones at his residence.”
