NO.PAS/LEGIS-B-26/2019- The Provincial Motor Vehicles (Amendment) Bill, 2019 having been passed by the Provincial Assembly of Sindh on 08th November, 2019 and assented to by the Governor of Sindh on 27th November, 2019 is hereby published as an Act of the Legislature of Sindh.

THE PROVINCIAL MOTOR VEHICLES (AMENDMENT) ACT, 2019.

SINDH ACT NO. XIII OF 2019.

**AN
ACT**

to amend the Provincial Motor Vehicles Ordinance, 1965.

WHEREAS it is expedient to amend the Provincial Motor Vehicles Ordinance, 1965, in the manner hereinafter appearing; **Preamble.**

It is hereby enacted as follows:-

1. (1) This Act may be called the Provincial Motor Vehicles (Amendment) Act, 2019.

Short title and commencement.

(2) It shall come into force at once.

2. In the Provincial Motor Vehicles Ordinance, 1965, hereinafter referred to as the said Ordinance, in section 2, in sub-section (15), after the words "defect or disability", the words "including differently abled persons with hearing impairment" shall be inserted.

Amendment of section 2 of the West Pakistan Ordinance No.XIX of 1965.

3. In the said Ordinance, in section 7, in sub-section (5), in the proviso, after clause (b), the following shall be added:-

Amendment of section 7 of the West Pakistan Ordinance No.XIX of 1965.

"(c) the applicant with hearing impairment having up to 40 DB hearing loss shall wear hearing aids and in case the hearing loss exceeds 40 DB, the applicant shall use assistive technology devices or means as per description vehicle of special type mentioned in Form-A(k) of First Schedule."

"(d) the person who will take the driving test should know sign language or should be assisted by a person who knows sign language.

"(e) no license fee shall be charged from such person.

Provided that the vehicles of such persons shall attach mandatory stickers on their vehicles, as may be prescribed.

4. In the said Ordinance, in the Second Schedule, serial No.5 shall be omitted.
