NO.PAS/LEGIS-B-16/2019-The Sindh Institute of Ophthalmology and Visual Sciences (Amendment) Bill, 2019 having been passed by the Provincial Assembly of Sindh on 13<sup>th</sup> November, 2019 and assented to by the Governor of Sindh on 27<sup>th</sup> November, 2019 is hereby published as an Act of the Legislature of Sindh.

### THE SINDH INSTITUTE OF OPHTHALMOLOGY AND VISUAL SCIENCES (AMENDMENT) ACT, 2019

SINDH ACT NO. XIV OF 2019

#### AN ACT

to amend the Sindh Institute of Ophthalmology and Visual Sciences Act, 2013.

**WHEREAS** it is expedient to amend the Sindh Institute of Ophthalmology and Visual Sciences Act, 2013, in the manner hereinafter appearing; **Preamble.**

It is hereby enacted as follows:-

1. (1) This Act may be called the Sindh Institute of Ophthalmology and Visual Sciences (Amendment) Act, 2019.

**Short title and commencement.**

(2) It shall come into force at once.

2. In the Sindh Institute of Ophthalmology and Visual Sciences Act, 2013, hereinafter referred to as the said Act, throughout the Act, for the word "Director", the words "Executive Director" shall be substituted.

3. In the said Act, in section 3, after sub-section (2), the following new sub-section shall be added:-

"(3) The Institute of Ophthalmology and Visual Sciences shall be an independent degree awarding Institute."

4. In the said Act, in section 5 -

(a) for clause (iv), the following shall be substituted:-

"(iv) to undertake postgraduate teaching and training programme such as M.S., MCPS, FCPS, Ophthalmology and Visual Sciences, diploma in Ophthalmology, B.S. (Visual Sciences) and Ph.D. in Ophthalmology in collaboration with College of Physicians and Surgeons of Pakistan and affiliated Medical or Health Sciences University recognized under Higher Education Commission and in accordance with Pakistan and Medical Dental Council criteria";

(b) after clause (iv), the following new clauses shall be inserted:-

"(iv-a) to undertake undergraduate teaching and training programme in the subject of ophthalmology;

(iv-b) to hold examinations and to award and confer degree, in Ophthalmology and Visual Sciences diploma certificate and other academic distinctions to and on the persons who have been admitted to and have passed its examinations under prescribed conditions;

(iv-c) to establish the satellite ophthalmology centers of the Institute at other districts of the Province of Sindh and to operate a regional centre of excellence and tertiary level facility in any taluka or district and to administer the eye units or hospitals in the Province of Sindh as may be considered necessary or expedient by Government;

(iv-d) to coordinate and collaborate with Provincial, National and International organizations in the field of ophthalmology with the approval of the Board;";

(iv-e) Eye Hospital Khairpur be handovered to the Sindh Institute of Ophthalmology and Visual Sciences.



5. In the said Act, in section 7, in sub-section (1), for the word "Governor", the words "Chief Minister" shall be substituted.

7. In the said Act, in section 10, for sub-section (1), the following shall be substituted:

- (1) The Board shall meet at least twice in a year with gap of at least three months on the date to be fixed by the Executive Director and shall be communicated to Chairman at least two weeks in advance. The meetings of the Board shall be held at the Institute.
