

SINDH ORDINANCE NO.VII OF 1970

THE SIND SPECIAL TRIBUNAL (AMENDMENT) ORDINANCE, 1970

[19th September, 1970]

An Ordinance to amend the Sind Special Tribunal Ordinance, 1970.

WHEREAS it is expedient to amend the Sind Special Tribunal Ordinance, 1970, in the manner hereinafter appearing; **Preamble.**

NOW, THEREFORE, in pursuance of the Martial Law Proclamation of 25th March, 1969, read with the Provisional Constitution Order, and in exercise of all powers enabling him in that behalf, the Governor of Sind is pleased to make and promulgate the following Ordinance :-

1. This Ordinance may be called the Sind Special Tribunal (Amendment) Ordinance, 1970. **Short title.**

2. In the Sind Special Tribunal Ordinance, 1970, hereinafter referred to as the Principal Ordinance, for sub-section (2) of section 5, the following sub-section shall be substituted and shall be deemed always to have been so substituted:- **Amendment of section 5 of Sind Ordinance III of 1970.**

“(2) The provisions contained in section 197 of the Code of Criminal Procedure, 1898 (Act V of 1898), and sub-section (5) of section 6 of the Pakistan Criminal Law Amendment Act, 1958) Act XL of 1958) shall not apply to the trial of scheduled cases by the Special Tribunal.”

3. For the existing Schedule to the Principal Ordinance, the Schedule appended to this Ordinance shall be substituted and shall be deemed always to have been so substituted. **Substitution of Schedule of Sind Ordinance III of 1970.**
