#### THE SIND FINANCE ACT, 1973

[29<sup>th</sup> July 1973]

and

**An Act** to levy or enhance certain taxes and duties in the Province of Sind.

WHEREAS it is expedient to levy or enhance certain Preamble taxes and duties in the Province of Sind in the manner hereinafter appearing;

It is hereby enacted as follows: —

- 1. (1) This Act may be called the Sind Finance Act, 1973. Short title extent
  - (2) It extends to the whole Province of Sind.

 (2) If extends to the whole frowhice of sind.
(3) It shall come into force on and from the 1st day of July, 1973

2. In this Act, unless the context other-wise requires, the **Definitions.** following expressions shall have the meanings hereby respectively assigned to them, that is to say—

- (a) "Government" means the Government of Sind;
- (b) "prescribed" means prescribed by rules made under this Act;

3. In the Sind Urban Immovable Property Tax Act, 1958 (West Pakistan Act V of 1958), in section 3—

- (a) in sub-section (2), for the word "paid", the word 1958. "collected" shall be substituted and shall be deemed to have always been so substituted;
- (b) after sub-section (3), the following new sub-sections shall be inserted, namely: —

"(3-A) There shall be levied and collected a betterment tax on buildings and lands used partly or exclusively for commercial or industrial purposes at the following scale: —

- (i) Plot for Commercial Ten paisa per square foot of purpose. covered area.
- (ii) Plot for Industrial Five paisa per square foot of purpose. covered area

(3-B) A plot for commercial purpose measuring upto 120 square yards and a plot for industrial purpose measuring upto 400 square yards in any rating area or part thereof shall be exempt from the tax under sub-section (3-A)".

4. In the West Pakistan Entertainments Duty Act, 1958 (West Pakistan Act X of 1958), in its application to the Province of Sind-

(1) in section 6-A-

(a) in sub-section (1)—

- the words, figures and comma "or in section 8 of the (i) West Pakistan Finance Ordinance, 1969" shall be omitted:
- (ii) in clauses (a) and (b), the words, figures and comma "and the Welfare Cess under the West Pakistan Finance Ordinance, 1969" shall be omitted; and
- (iii) in clause (c), the words, figures and commas "and the Welfare Cess under section 8 of the West Pakistan Finance Ordinance, 1969," shall be omitted.
- (b) in sub-sections (2), (5), (6) and (8) and proviso to sub section (8), the words "and the Welfare Cess" shall be omitted;
- (c) in sub-section (4), the words, figures and commas "and the Welfare Cess under the West Pakistan Finance Ordinance, 1969," shall be omitted; and
- (d) clause (b) of the explanation shall be omitted; and
- (2) in the heading of column 2 of the Schedule, the words "and Welfare Cess" shall be omitted.

In the West Pakistan Finance Act, 1963, (West Pakistan Amendment of 5. Act IX of 1963), in its application to the Province of Sind, in the the Schedule, in seventh the column of rate of tax-

- (a) For the figures and words " $7^{1/2}$  per cent", the figures and words "10 per cent" shall be substituted, and
- (b) For the figure and words "10 per cent", figures and words "15 per cent" shall be substituted.

In the West Pakistan Finance Act, 1964, (West Pakistan 6. Act XXXIV of 1964), in its application to the Province of Sind, in section 12, in sub-section (1) and the proviso thereto, for the words "twelve paisa", the words "eighteen paisa" shall be substituted.

In the West Pakistan Finance, 1969, (West Pakistan 7. Ordinance VII of 1969), in its application to the Province of Sind, in sub-section (1) of section 8-

(a) In clause (i), for the words "Ten paisa per ticket", the

(b) in clause (ii), for the words "One rupee per ticket", the words "two rupees per ticket" shall substituted.

8. No suit shall lie in any civil court to set aside or modify any assessment, levy or collection of the taxes and cesses made under this Act and the rules framed thereunder.

9. Government may make rules for carrying into effect the purposes of this Act and such rules may among other matters, prescribe the procedure for the assessment, collection and payment of the taxes and cesses levied under this Act.
