NO.PZA/SO(R&P)/II/XXXVI/84 : In exercise of the powers conferred by section 26 of the Zakat and Ushr Ordinance, 1980 read with sub-section (7) of section 21 thereof, and at the direction and with the approval of the Central Zakat Council, the Sind Zakat Council is pleased to make the following rules namely:-

1. (1) These rules may be called the Sind Zakat Short title and Committees (Chairman and Members) (Review commencement. Application) Rules, 1985.

(2) They shall come into force at- once.

2. In these rules, unless there is anything repugnant Definitions. in the subject or context-

- (a) "Chairman" means the Chairman of a Committee;
- (b) "Committee" means a Committee constituted under the Ordinance;
- (c) "Council" means the Sind Zakat Council;
- (d) "member" means the member of a committee;
- (e) "Ordinance" means the Zakat and Ushr Ordinance, 1980;
- (f) "section" means a section of the Ordinance.

3. The Chairman or member who has ceased to hold office under sub-section (2) of section 21 or has been removed under sub-section (3) of section 21 may, within thirty days of such cessation or removal, as the case may be, apply to the Council for review of its decision. Filing of application for review.

4. The application for review may be made on plain paper addressed to the Council, and shall be presented to the Secretary to the Council. Form and manner for filing an application for review.

5. (1) The Council shall consider the application in its meeting held next after receipt of the application for review and cause a notice to be issued to the applicant to appear before the Council for being heard in the meeting to be held on such date, time and place as may be specified in the notice. Disposal of application for review.

(2) The Council shall consider and decide the application in the meeting held in pursuance of sub-rule (1) after hearing the applicant, and if the applicant fails to appear before the Council, though duly served with the notice, the Council may decide the matter *ex parte*.

(3) The decision on the application shall be in the form of a resolution and a copy of such resolution shall be communicated to the applicant.

(4) Where the Council decides the application in favour of the Chairman or member, as the case may be, he shall be reinstated with effect from the date indicated in this behalf in the resolution.

EXPLANATION: In these rules reference to the Council shall, where the powers of the Council are exercised by the District Committee in pursuance of sub-section (6) of section 21, be construed as reference to the District Committee.
