## NOTIFICATION

Karachi, the 3<sup>rd</sup> December, 1986

No. PRS/1-13/86.—In exercise of the powers conferred by section 7 of the Execution of the Punishment of Whipping Ordinance, 1979, the Government of Sind are pleased to make the following rules, namely:-

### THE SIND EXECUTION OF THE PUNISHMENT OF WHIPPING RULES, 1986.

1. (1) These rules may be called the Sind Execution of the Punishment of Whipping Rules, 1986. **Short title and commencement.**
  - (2) They shall come into force at once.
2. In these rules unless there is anything repugnant in the subject or context— **Definitions.**
  - (a) “Government” means the Government of Sind;
  - (b) “Ordinance” means the Execution of the Punishment of Whipping Ordinance, 1979.

3. (1) The Inspector General of Prisons shall nominate a panel of persons from amongst Warders or other jail Staff who possess mature understanding and are willing to execute the punishment of whipping; **Panel of persons for execution of punishment.**

Provided that punishment of whipping on females shall be executed by a female.

(2) The whipping on a woman shall not be visible to or witnessed by any male person.

4. The objection of the convict with regard to partiality of the person appointed under sub-rule (1) of rule 3 shall be heard and rectified if found valid. **Objection of the convict.**

5. The required number of whips of the specification mentioned in Section 4 of the Ordinance, shall be arranged by the Inspector General of Prisons, who shall also arrange for their maintenance and storage. **Provision for whips**
