

**SIND ORDINANCE NO. III OF 1983**

**THE SIND MINISTERS (SALARIES, ALLOWANCES AND PRIVILEGES)ACT, 1975  
( THE SINDH MINISTER (SALARIES, ALLOWANCES AND PRIVILEGES)(AMENDMENT) ORDINANCE, 1983**

[19<sup>th</sup> February, 1983]

**An Ordinance** to amend the Sind Ministers (Salaries, Allowances and Privileges) Act, 1975

**WHEREAS** it is expedient to amend the Sind Ministers (Salaries Allowances and Privileges) Act, 1975, in the manner hereinafter appearing;

**NOW, THEREFORE**, in pursuance of the Proclamation of the fifth day of July, 1977 and the Provincial Constitution Order, 1981, the Governor of Sind is pleased to make and promulgate the following Ordinance :-

- (1) This Ordinance may be called the Sind Ministers (Salaries, Allowances and Privileges) (Amendment) Ordinance, 1983.  
(2) It shall come into force at once and shall be deemed to have taken effect on and from 1<sup>st</sup> January, 1983.

- In the Sind Ministers (Salaries, Allowances and Privileges) Act, 1975, hereinafter referred to as the Said Act, after section 3, the following shall be inserted I—

**Equipment allowance**

“3-A. A Minister shall, on his first appointment, be entitled to equipment allowance of three thousand rupees.”

- In the said Act, in section 5, for the word “shall respectively be three thousand rupees and two thousand five hundred rupees per mensem” the words “shall be three thousand rupees per mensem” shall be substituted.

- In the said Act, in section 6, for the words “one thousand rupees” the words “one thousand and five hundred rupees” shall be substituted.

- In the said Act, after section 6, the following shall be inserted:-

**Discretionary Grant**

“6-A A Minister may in his discretion make grants to the extent of seven thousand and five hundred rupees in a year.”

( THE SINDH MINISTER (SALARIES, ALLOWANCES AND PRIVILEGES)(AMENDMENT) ORDINANCE, 1983**

- (i) in sub-section (1) for the words "shall be provided with official Residence" the words "shall be provided with free furnished official residence" "shall be substituted;
- (ii) in sub-section (3), in clause (a), for word "thirty thousand rupees" the words "forty thousand rupees" shall be substituted.

7. In the said Act, after section 8, the following shall be inserted:-

**Insertion of section 8-A in Sind Act VIII of 1975.**

"8-A. A Minister shall be entitled to telephone facilities at his office and residence at Government expense without ceiling."

8. In the said Act, the existing section 16 shall be renumbered as sub-section (1) of that section and thereafter the following shall be added:-

**Amendment of section 16 of Sind Act VIII of 1975.**

"(2) A Minister shall be entitled to receive leave salary of three thousand rupees per mensem".
