NOTIFICATION

No.SOIII(I&MD)/12-13/90.—With reference to the Industries and Mineral Development Department's notification of even number dated 24th June, 1990 and in exercise of the powers conferred by section 29 read, with section 31 of the Boilers Act, 1923, the Government of Sindh are pleased to make the following rules:-

1. (1) These rules may be called the Sindh Boilers (Renewal Certificate Fees) Rules, 1990. **Short title and commencement.**

(2) They shall come into force on and from the 1st day of July, 1990.

2. The fees for the issue of renewal certificates in respect of the boilers of the capacities mentioned in Column 1 of the table below shall be payable at the rates mentioned against each in Column 2 thereof. **Renewal Certificates fees.**

4. Any contravention of these rules shall be punishable under Section 30 of the Boilers Act, 1923. Penalty
